> 2021年6月23日黎巴嫩常驻联合国代表给秘书长和安全理事会主席的 同文信

奉黎巴嫩政府指示, 谨通知你, 在联合国驻黎巴嫩临时部队小组在场的情况下, 黎巴嫩军队的一个委员会于 2020 年 11 月和 12 月不同日期, 在阿姆拉、希亚姆、胡拉、迈尔凯巴、迈斯杰贝勒、拉梅什、艾塔沙卜、杜哈拉和阿尔马萨阿布蓝线沿线 21 个地点, 对以前放置的桶的位置进行了最后核查。这些放置点的标记已获核准。

在对迈尔凯巴的 B76(1)点进行最后核查的过程中,发现在 B76(1)点和 B77 点之间发生了一例以色列越过蓝线的情况,越线点系一条有技术围栏的土路。这 是 18 起违规事件中的一起,包括在蓝线沿线地区发生的 4 起(包括在黎巴嫩主张拥有主权的雅伦、欧代塞和阿姆拉发生的 2 起)违规事件。以色列在这些地区的违规行为,除了占领蓝线以南的黎巴嫩地区之外,还包括延伸到蓝线以北的违规事件,其中包括在纳古拉和马利的 2 起永久性违规行为,如附件所示。*

黎巴嫩方面要求立即消除这些违规行为。黎巴嫩重申要求以色列撤出蓝线以南和以北所有被占领的黎巴嫩地区,并消除在蓝线沿线地区的4起永久性违规行为(黎巴嫩对该地区的雅伦、欧代塞和阿姆拉主张拥有主权)以及在纳古拉和马利的2起违规行为。在得到清除之前,所有18起违规行为都将被视为永久违反安全理事会第1701(2006)号决议和侵犯黎巴嫩主权的行为。
