Land violations committed in August 2021

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 August	0715	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	An Israeli enemy patrol consisting of a Humvee vehicle, a four-wheel drive vehicle and dump truck carrying dirt and basecourse material stopped inside the occupied Shab'a Farms, in the area of Saddanah. Enemy personnel used two trench excavators to continue levelling the dirt road. They were accompanied by soldiers who deployed in the surrounding area and took up combat positions. Work ended at 1630 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.
	2140	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers directed searchlights towards Lebanese territory.
2 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Duhayrah, 1 in Bustan, 24 in Amra and 21 in Hula.
	0715	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0830	An Israeli enemy patrol consisting of a Humvee vehicle, two four-wheel drive vehicles, a personnel carrier and a truck stopped inside the occupied Shab'a Farms, in the locality of Saddanah, opposite point OP4 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL). Enemy personnel used two trench diggers to continue levelling the dirt road and to excavate a trench approximately 100 m long and 1 m deep. They were accompanied by soldiers who deployed in the surrounding area and took up combat positions. Work ended at 1630 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.

		2110 From occupied Palestinian territory, near the town of Maysat, Israeli enemy soldiers fired two flares that fell in Lebanese territory.
3 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Alma al-Sha'b, 4 in Duhayrah, 41 in Yarun, 14 in Amra, 32 in Hula and 1 in Mays al-Jabal.
	0630	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0830	An Israeli enemy patrol consisting of a Humvee, a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle, a personnel carrier and a truck stopped inside the occupied Shab'a Farms, opposite the Ruwaysat al-Alam position. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, continued levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position, and they used two trench diggers to excavate a trench approximately 60 m long and 1 m deep. Work ended at 1730 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.
	1320	As the civilian Hasan Zahrah was grazing a herd of livestock in the vicinity of the town of Shab'a, in the Sha'b al-Suwayd area, an Israeli enemy patrol directed light weapons fire into the air towards Lebanese territory from the perimeter of the enemy's Birkat al-Naqqar position, in order to intimidate the shepherd. No one was harmed in the incident.
	1803	In occupied Palestinian territory, opposite the town of Udaysah, two Israeli enemy soldiers pointed their weapons towards Lebanese territory.
	2107	From occupied Palestinian territory, opposite Birkat Risha and the town of Bustan, the Israeli enemy fired 12 flares, 5 of which fell in Lebanese territory.
	2235	From occupied Palestinian territory, at the southern boundary of the town of Aytarun, Israeli enemy soldiers fired a flare that fell in Lebanese territory.
4 August	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.

	0840	In the occupied Shab'a Farms, in the area of Birkat al-Naqqar, enemy personnel completed levelling and cleaning the dirt road leading to Tallat al-Saddanah, and they used an excavator to split boulders. The work ended at 1640 hours.
	1215	<p>The Israeli enemy fired artillery shells that fell in Lebanese territory as follows:</p> <p>From 1215 to 1230 hours, eight shells fell in Sahl al-Khiyam.</p> <p>Between 1345 and 1502 hours, 24 shells fell in the outskirts of the town of Rashayya al-Fukhar (at Wadi al-Hayr and Khuraybah), causing fires to break out in Khuraybah; 22 shells fell outside the town of Habbariyah (in the area around Birkat al-Saddanah); 18 shells fell outside the town of Naqurah (at Tallat Umm al-Rabb); and 8 shells fell outside the town of Tayr Harfa (at Ayn al-Zarq).</p>
5 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Duhayrah and 41 in Yarun.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0900	In the occupied Shab'a Farms, in the area of Birkat al-Naqqar, enemy personnel completed levelling and cleaning the dirt road leading to Tallat al-Saddanah, and they used an excavator and a truck to split boulders. The work ended at 1600 hours.
	2330– 0015	The rumble of several explosions, the cause of which is unknown, was heard coming from the occupied Shab'a Farms.
6 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Duhayrah, 30 in Yarun, 10 in Hula and 19 in Amra.
	1115	The Israeli enemy fired 45 155-mm shells towards the Saddanah area, of which 30 fell outside the town of Habbariyah and 15 outside the town of Kafr Shuba, in the area of Izra'il. Residents extinguished the fires that broke out.
7 August	–	Some seven landmines that the Israeli enemy had left behind in the town of Hula were detonated.
8 August	0715	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the

	1045– 1200	The rumble of several explosions, the cause of which is unknown, was heard coming from the occupied Shab'a Farms.
9 August	0715	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
10 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 2 in Mays al-Jabal, 31 in Amra, 15 in Hula and 12 Duhayrah.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
11 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 19 in Mays al-Jabal, 19 in Hula, 8 in Duhayrah and 34 in Yarun.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0830	An Israeli enemy patrol consisting of a Humvee, a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle and a personnel carrier stopped inside the occupied Shab'a Farms, opposite the Ruwaysat al-Alam position. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, used three trench diggers to continue levelling the dirt road leading to the enemy's Ruwaysat al-Alam position. Work ended at 1700 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.
	1200	Opposite the town of Kafr Kila, a civilian bus and four civilian vehicles approached from the enemy's Jabal al-Tayyarah position in occupied Palestinian territory. Some 40 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1250 hours.

	0930	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1000	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
13 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Mays al-Jabal, 13 in Hula, 5 in Duhayrah, 7 in Marwahin and 26 in Yarun.
	0900	In occupied Palestinian territory, opposite the town of Wazzani, at the Israeli enemy's Humayri position, the cannon of a Merkava tank was pointed towards Lebanese territory until 0935 hours.
	1330	In occupied Palestinian territory, opposite the town of Udaysah, near point TP36(2), Israeli enemy soldiers pointed their weapons towards Lebanese territory.
14 August	1015	In occupied Palestinian territory, opposite the town of Wazzani, at the Maysat point, Israeli enemy soldiers pointed their weapons towards Lebanese territory.
15 August	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	An Israeli enemy patrol consisting of a Humvee vehicle, a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle and a truck stopped inside the occupied Shab'a Farms, opposite point OP3 of the Indian contingent of UNIFIL. Enemy personnel, escorted by soldiers who deployed in the surrounding area and took up combat positions, used three trench diggers to continue levelling the dirt road leading to Tallat al-Saddanah and laid basecourse material in the trench next to the road. Work ended at 1630 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.

Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
17 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 26 in Yarun, 28 in Hula and 27 in Amra.
	1310	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 16 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	2315– 2335	The sound of several explosions and light machine-gun fire was heard emanating from inside the occupied Shab'a Farms, in the area of the Israeli enemy's Summaqah and Ruwaysat al-Alam positions.
18 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 24 in Mays al-Jabal, 39 in Yarun, 14 in Hula and 1 in Rabb al-Thalathin.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0900	In occupied Palestinian territory, opposite the town of Wazzani, at the Israeli enemy's Humayri position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
19 August	0800	An Israeli enemy patrol consisting of a Humvee, a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle, a personnel carrier and two trucks stopped inside the occupied Shab'a Farms, in the area of Saddanah. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, used three trench diggers to continue levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position, and laid basecourse material in the trench next to the road. Work ended at 1630 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.

	1030	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at the site, while the other seven took up positions along the dirt road and pointed their weapons towards Lebanese territory.
20 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 25 in Yarun, 17 in Hula and 26 in Amra.
	1530	A four-soldier Israeli enemy patrol unsuccessfully attempted to abduct the civilian Mahir Hamdan as he was grazing some 300 head of livestock outside the town of Shab'a, in the Saddanah area, opposite Birkat al-Naqqar. The soldiers detained the herd and took it into occupied territory.
22 August	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0930	As the civilian Marwan Atwi was herding livestock outside the town of Kafr Shuba, at Jabal al-Saddanah, opposite point OP4 of the Indian contingent of UNIFIL, Israeli enemy patrol members fired in the air in the direction of Lebanese territory and over the herder's head. No one was injured.
23 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 32 in Mays al-Jabal, 13 in Hula and 41 in Yarun.
	0715	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0730	Opposite the town of Wazzani, next to point OP8, an Israeli enemy patrol consisting of two Humvee vehicles, two military four-wheel drive vehicles and a Merkava tank approached from occupied territory. Some 20 individuals in military clothing and a dog disembarked. They opened a metal gate in the technical fence and passed through it, and then conducted a foot patrol along the river, proceeding as far as the Maysat point. Meanwhile, the tank's cannon was pointed towards Lebanese territory. At 1910 hours, they closed the gate and left in the direction of occupied territory.

	0745–0810	The sound of light and medium machine-gun fire was heard emanating from inside the occupied Shab'a Farms, in the area of the Israeli enemy's Summaqah and Ruwaysat al-Alam positions.
	0800	An Israeli enemy patrol consisting of two white four-wheel drive vehicles, a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle, a personnel carrier and a white fuel tanker stopped inside the occupied Shab'a Farms, in the area of Saddanah. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, used three trench diggers, an olive-coloured wheel loader and two dump trucks to continue levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position, and they laid basecourse material in the trench next to the road. Work ended at 1700 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.
24 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Mays al-Jabal, 24 in Yarun, 9 in Duhayrah, 16 in Hula and 14 in Amra.
	0800	An Israeli enemy patrol consisting of a black four-wheel drive vehicle, an olive-coloured four-wheel drive vehicle, two white four-wheel drive vehicles and an armoured personnel carrier stopped inside the occupied Shab'a Farms, in the area of Saddanah. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, used three trench diggers, an olive-coloured wheel loader and two yellow dump trucks to continue levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position, and they laid basecourse material in the trench next to the road. Work ended at 1700 hours. The construction vehicles remained where they were, while the patrol left and headed towards occupied territory.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0920	Opposite the town of Kafr Kila, a civilian bus and a civilian vehicle approached from the enemy's Jabal al-Tayyarah position in occupied Palestinian territory. Some 30 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 0950 hours.
25 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Mays al-Jabal, 35 in Yarun, 2 in Duhayrah, 38 in Marwahin and 13 in Hula.
	0800	An Israeli enemy patrol consisting of an olive-coloured four-wheel drive vehicle, a black four-wheel drive vehicle, two white four-wheel drive vehicles and an armoured personnel carrier stopped inside the occupied Shab'a Farms, in the area of Saddanah. Enemy personnel, escorted by soldiers who deployed in the area and took up combat positions, used two trench diggers, an olive-coloured bulldozer, a JCB bulldozer and two

		yellow trucks to continue levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position, and they filled up the trench next to the road. 	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
26 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 25 in Mays al-Jabal, 50 in Hula, 31 in Amra, 7 in Duhayrah, 8 in Bustan and 35 in Yarun.
	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	An Israeli enemy patrol consisting of an olive-coloured four-wheel drive vehicle, a black four-wheel drive vehicle, two white four-wheel drive vehicles and an armoured personnel carrier stopped inside the occupied Shab'a Farms, in the area of Saddanah, opposite points OP3 and OP4 of the Indian contingent of UNIFIL.
