## رسالة مؤرخة 29 تشرين الأول/أكتوبر 2021 موجهة إلى الأمين العام من الممثل الدائم لقبرص لدى الأمم المتحدة

بناءً على تعليمات من حكومة بلدي، أحيل إليكم طيه ست وثائق مستقلة تسجل انتهاكات المجال الجوي الوطني لقبرص، وخروقات أنظمة الحركة الجوية الدولية داخل منطقة معلومات الطيران لقبرص، والاستخدام غير القانوني للموانئ والمطارات المغلقة في قبرص من قبل تركيا خلال أشهر حزيران/يونيه وتموز/يوليه وآب/أغسطس 2021 (انظر المرفقات الأول إلى السادس)\*.

ولا يزال الطيران المدني الدولي يواجه حالة لا تراعي فيها إحدى الدول الأعضاء في منظمة الطيران المدني الدولي، وهي تركيا، الأحكام الأساسية لاتفاقية الطيران المدني الدولي ومرفقاتها، ما يسبب مخاطر محتملة للملاحة الجوية الدولية. وتواصل تركيا بشكل ممنهج مضايقة الطائرات المدنية والعسكرية داخل منطقة نيقوسيا لمعلومات الطيران بواسطة الاتصالات اللاسلكية. وعلاوة على ذلك، أصدرت تعليماتها إلى النظام الانفصالي الذي أقامته في منطقة قبرص الخاضعة لاحتلال تركيا العسكري غير القانوني بأن يدعي توجيه ستة مما يُسمى بـ "إخطارات للطيارين" تتعلق بمناورات تجريها القوات الجوية التركية.

وتهدف أعمال تركيا هذه إلى تقويض سيادة قبرص، وتعزيز التقسيم الفعلي الحالي للجزيرة، ومحاولة تحسين وضع نظام الاحتلال من خلال الوجود المزعوم لمجال جوي منفصل فوق الإقليم المحتل من قبرص. والواقع أنها جزء من نمط منتظم ومستمر من الانتهاكات غير القانونية لسيادة قبرص وسلامتها الإقليمية.

ومن دواعي الأسف، وعلى الرغم من الرسائل الواضحة التي بعث بها مجلس الأمن في تموز/يوليه الماضي، فسلوك تركيا العدواني وازدراؤها المستمر للقانون الدولي قد وصلا مؤخراً إلى مستويات عالية جديدة من الجرأة غير المسؤولة والاستفزازية:

(أ) في 3 تشرين الأول/أكتوبر 2021، قامت سفينتان حربيّتان تركيتان بمضايقة ومنع سفينة المسح “NAUTICAL GEO” - المرخص لها على النحو الواجب من السلطات المختصة في جمهورية قبرص - من إجراء مسح بشأن المسار المحتمل لمشروع مدّ خط أنابيب الغاز في شرق البحر الأبيض المتوسط (EASTMED PIPELINE PROJECT)، وهو خطة للطاقة ذات أهمية إقليمية، تم تصنيفها كمشروع ذوي أهمية مشتركة بالنسبة للاتحاد الأوروبي.

(ب) في 13 تشرين الأول/أكتوبر 2021، بدأ نظام الاحتلال التركي أعمال بنى تحتية واسعة النطاق في ما يسمى “المنطقة التجريبية” في مدينة فاروشا المسيجة، في تجاهل تام للدعوة الواضحة التي وجهها مجلس الأمن في تموز/يوليه الماضي (S/PRST/2021/13) إلى الجانب التركي لوقف وعكس انتهاكات الوضع الراهن في فاروشا.

(ج) في 15 تشرين الأول/أكتوبر 2021، “منح” النظام الانفصالي في المنطقة المحتلة من قبرص قوات الاحتلال التركية 145 كيلومترا مربعا من الأراضي في شبه جزيرة كارباس، التي تعود ملكيتها قانونا إلى النازحين القبارصة اليونانيين، وذلك على ما يبدو لغرض بناء قاعدة بحرية تركية. ومن شأن هذه الخطوة، بالاقتران مع القاعدة التركية للطائرات بدون طيار، التي تعمل بالفعل بصورة غير قانونية في المنطقة المحتلة من قبرص، أن تشكل خطوة أخرى في عملية تعزيز الخطة التركية المزعجة للاستقرار المتمثلة في الهيمنة العسكرية في شرق البحر الأبيض المتوسط.

ويصاحب أعمال تركيا المزعجة للاستقرار في الميدان خطاب عدواني، عادة ما يتضمن اتهامات مغالطة ضد أهداف السلوك العدواني التركي ذاته، وحججا زائفة ضد قرارات مجلس الأمن، التي تصفها تركيا بأنها عفا عليها الزمن لأنها ببساطة لا تتناسب مع وجهة النظر التركية، وتدعو “المجتمع الدولي إلى مواجهة الحقائق على أرض الواقع”.

ومن الواضح أن تركيا تعتقد أن ما يُسمى بـ “الحقائق على أرض الواقع” تتمثل بالفعل في ذلك الوضع الذي استحدثته هي في قبرص باستخدام القوة، في انتهاك للمادة 2 من ميثاق الأمم المتحدة، ومن خلال الاحتلال العسكري لثلث إقليم جمهورية قبرص. وتطالب تركيا المجتمع الدولي بالاعتراف بالتغيرات التي تمخض عنها العدوان، تمشيا مع المذهب البائد المتمثل في الحق في الغزو، وتعلن صراحة أنها ستواصل انتهاك قرارات مجلس الأمن، في تجاهل تام للمادة 25 من الميثاق.

ويجب أن يدعم مجلس الأمن قراراته ويحرص على أن تكون ذات مغزى؛ وإلا فإننا نجازف بتقويض مصداقية النظام الدولي.

ورغم كل هذه العقبات، ما زلنا ملتزمين بتسوية قائمة على أساس اتحاد ذي منطقتين وطائفتين تسوده المساواة السياسية، على النحو المحدد في قرارات مجلس الأمن. وفي هذا الصدد، نشعر بالتشجيع إزاء ما تتمّ عنه رسالة معاليكم من ثبات وعزم في الجهود المبذولة لاستئناف المفاوضات الرسمية، على النحو المُعرب عنه في تقاريركم الأخيرة المقدمة إلى مجلس الأمن.

وأرجو ممتنا تعميم هذه الرسالة ومرفقاتها باعتبارها وثيقة من وثائق الدورة العادية السادسة والسبعين للجمعية العامة، في إطار البند 44 من جدول أعمال، ومن وثائق مجلس الأمن.
