مسألة قبرص

رسالة مؤرخة 13 نيسان/أبريل 2022 موجهة إلى الأمين العام من الممثل الدائم لقبرص لدى الأمم المتحدة

بناءً على تعليمات من حكومة بلدي، أحيل إليكم طيه ثمان مرفقات تسجل انتهاكات المجال الجوي الوطني لقبرص، وخروقات أنظمة الحركة الجوية الدولية داخل منطقة معلومات الطيران لقبرص، وانتهاكات المياه الإقليمية لقبرص، والاستخدام غير القانوني للموانئ والمطارات المغلقة في قبرص من قبل القوات الجوية والبحرية لتركيا خلال أشهر أيلول/سبتمبر وتشرين الأول/أكتوبر وتشرين الثاني/نوفمبر وكانون الأول/ديسمبر 2021 (انظر المرفقات الأول إلى الثامن)*.

وبإيجاز، لوحظ وقوع 470 انتهاكاً جويًا و 27 انتهاكاً بحرياً خلال فترة الأشهر الأربعة هذه. وتجدر الإشارة إلى أن 140 من الانتهاكات الجوية الـ 470 تتعلق باستخدام مركبات جوية عسكرية غير مأهولة تركية.

وعلاوةً على ذلك، وقع حادثان آخران من حوادث العدوان التركي في المنطقة الاقتصادية الخالصة لقبرص في بداية عام 2022، إذ قامت فرق طائرات تركية في 15 و 20 كانون الثاني/يناير بمضايقة السفينة "NAUTICAL GEO" ومنعها من إجراء عمليات مسح مرخص بها من قبل السلطات المختصة في جمهورية قبرص.

وعلى أرض الواقع، تواصل تركيا سلوكها العدواني بلا هوادة، استناداً إلى وجود جيش الاحتلال التابع لها والعسكرة الشديدة للمناطق المحتلة من قبرص، بما في ذلك من خلال التحسينات المستمرة لبنيتها التحتية العسكرية، مثل قاعدة الطائرات المسيرة العسكرية في ليفكونيكو والقاعدة البحرية في بوغازي. وتلاحظ بانتظام محاولات جيش الاحتلال إحراز تقدم في المنطقة العازلة. ولا تزال تُفرض على قوة الأمم المتحدة لحفظ السلام في قبرص قيودٌ على الحركة، ويعرب النظام الانفصالي في تصريحات عامة عن تهديدات علنية بإزالة وجود عملية الأمم المتحدة لحفظ السلام من المناطق المحتلة.

وفي تجاهل تام للدعوة الواضحة التي وجهها مجلس الأمن (S/PRST/2021/13) إلى الجانب التركي للكف والعدول عن انتهاكات الوضع الراهن في فاروشا، يظل التغيير غير القانوني للمنطقة على صدارة خطة السلطة القائمة بالاحتلال والإدارة المحلية التابعة لها، اللتين تصرحان علناً بأنهما ستستغلان المنطقة اقتصادياً لمصلحتهما الخاصة، لتتماديا بذلك في المهانة المتمثلة في الطرد القسري للقبازصة اليونانيين من سكان فاروشا وسرقة ونهب ممتلكاتهم عقب الغزو التركي في عام 1974.

وبصاحب أعمال تركيا المزعومة للاستقرار في الميدان خطاباً عدواني، عادةً ما يتضمن اتهامات مغالطة ضد أهداف السلوك العدواني التركي ذاته، وحججاً زائفة ضد قرارات مجلس الأمن، التي تصفها تركيا بأنها عفا عليها الزمن لأنها ببساطة لا تتناسب مع الإملاءات التركية بشأن "حل الدولتين" المطروح، وتدعو "المجتمع الدولي إلى مواجهة الحقائق على أرض الواقع".

ومن الواضح أن تركيا تعتقد أن ما يُسمى بـ "الحقائق على أرض الواقع" تتمثل بالفعل في ذلك الوضع الذي خلقته هي في قبرص باستخدام القوة، في انتهاك للمادة 2 من ميثاق الأمم المتحدة، ومن خلال الاحتلال العسكري الجاري لثلث إقليم جمهورية قبرص. وتطالب تركيا المجتمع الدولي بالاعتراف بالتغيرات التي تخضع عنها العدوان، تمثيلاً مع المذهب البائد المتمثل في "الحق في الغزو"، وتعلن صراحةً أنها ستواصل انتهاك قرارات مجلس الأمن، في تجاهل تام للمادة 25 من الميثاق. ويبدو في جوهر الأمر أن تركيا تريد أن يعود العالم إلى زمن ما قبل قيام الأمم المتحدة حين كانت تحكم العالم الإمبراطورية العثمانية وغيرها من الإمبراطوريات.

ويجب أن يدعم مجلس الأمن قراراته ويحرص على أن تكون ذات مغزى؛ وإلا فإننا نجازف بتقويض مصداقية النظام الدولي. والأفعال التي تقوم بها تركيا منذ عام 1974 هي انتهاك لسلامة أراضي قبرص وسيادتها. والسيادة والسلامة الإقليمية لأي دولة عضو في الأمم المتحدة هي أمر يحميه ويضمنه ميثاق الأمم المتحدة. وتُظهر الأفعال التي تقوم بها تركيا ازدراء صارخاً للقانون الدولي.

ورغم كل هذه العقبات، ما زلنا ملتزمين بتسوية قائمة على أساس اتحاد ذي منطقتين وطائفتين تسوده المساواة السياسية، على النحو المحدد في قرارات مجلس الأمن. وفي هذا الصدد، نشعر بالتشجيع إزاء ما تتمّ عنه رسالتكم من ثبات وعزم في الجهود المبذولة لاستئناف المفاوضات الرسمية، على النحو المُعرب عنه في تقاريركم الأخيرة إلى مجلس الأمن.

وأرجو ممتناً تعميم هذه الرسالة ومرفقاتها باعتبارها وثيقة من وثائق الجمعية العامة، في إطار البند 44 من جدول الأعمال، ومن وثائق مجلس الأمن.
