**Land violations committed in March 2022**

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 29 in Alma al-Sha'b, 55 in Yarun, 2 in Marwahin, 5 in Duhayrah, 16 in Arab al-Luwayzah, 39 in Amra and 17 in Markaba.
	1415	In occupied Palestinian territory, opposite the town of Kafr Kila near point B82, an Israeli enemy civilian bus approached. Some 15 soldiers in military uniform disembarked, scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1500 hours.
2 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 23 in Alma al-Sha'b, 31 in Yarun and 11 in Marwahin.
	1120	Inside occupied Palestinian territory opposite the town of Yarun, Israeli enemy personnel pointed two Merkava tank cannons in the direction of Lebanese territory.
	1510	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy personnel directed offensive gestures towards Lebanese army personnel.
	1640	In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy patrol consisting of eight soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1700 hours.
3 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 40 in Alma al-Sha'b.
	–	In occupied Palestinian territory, opposite the town of Alma al-Sha'b near point B10, Israeli enemy personnel set up a camera equipped with an antenna mounted on a metal tripod next to the military dirt road and pointed it towards Lebanese territory.
	–	In occupied Palestinian territory, opposite the town of Marwahin and point M4, Israeli enemy personnel set up a camera on a wooden post and pointed it at Lebanese territory.
4 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 38 in Alma al-Sha'b, 9 in Marwahin and 7 in Duhayrah.
5 March	0900	In the occupied Shab'a Farms at Bastarah, opposite the Israeli enemy Zabdin position, near the concrete blocks, a Merkava tank approached. Eight soldiers disembarked and took up combat positions. The tank and soldiers left in the direction of the aforementioned position at 0930 hours.
	1205	In occupied Palestinian territory, opposite the outskirts of the town of Hula and point B71, an Israeli enemy Humvee vehicle approached. Two soldiers disembarked and one of them fired shots in the air in the direction of Lebanese territory to scare three civilians who were present on the outskirts of the town, without injuring anyone. The enemy vehicle left in the direction of occupied territory at 1210 hours.

7 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 31 in Alma al-Sha'b, 16 in Marwahin and 8 in Duhayrah.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon three patrol members took up positions inside the emplacement situated at the site, while the other 10 took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1000	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel began to install metal pegs at a height of approximately four metres, affixing them to the old technical fence with concrete. The work ended at 1500 hours.
8 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 31 in Alma al-Sha'b, 41 in Yarun, 16 in Marwahin, 14 in Duhayrah, 50 in Amra, 20 in Markaba, 19 in Hula and 4 in Arab al-Luwayzah.
	0930	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, installing metal pegs at a height of approximately four metres and affixing them to the old technical fence with concrete using a crane. The work ended at 1500 hours.
	0950	Inside occupied Palestinian territory opposite the town of Aytarun, 12 Israeli enemy soldiers crossed the technical fence, escorted by a Merkava tank that pointed its cannon in the direction of Lebanese territory and Lebanese Army personnel until 1140 hours.
	1400	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of approximately 20 soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1430 hours.
9 March	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel installed approximately 100 metres of metal netting, which they attached to previously installed pegs using a crane. The work ended at 1700 hours and the crane left in the direction of occupied territory.
10 March	0900	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, installing an approximately 100-metre barbed wire (concertina) strip. The work ended at 1600 hours.
	1335	Inside occupied Palestinian territory, opposite the town of Mays al-Jabal, two Israeli enemy soldiers pointed their weapons towards civilians located on the Lebanese side.
13 March	0900	In the occupied town of Ghajar, opposite the town of Wazzani, at the water pumps, Israeli enemy personnel cleared brush from the road leading to the pumps using a trench digger that crossed the Blue Line. The work ended at 1415 hours and the personnel left in the direction of occupied territory.
14 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 23 in Alma al-Sha'b and 12 in Duhayrah.

	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, attaching metal netting to pegs at a height of approximately four metres using a crane. The work ended at 1330 hours.
15 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 28 in Alma al-Sha'b.
	0900	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished their reinforcement of the technical fence, installing an approximately 300-metre barbed wire (concertina) strip using a crane. The work ended at 1700 hours.
	1000	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy patrol consisting of 20 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1040 hours.
16 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 24 in Alma al-Sha'b, 7 in Marwahin and 10 in Duhayrah.
	0830	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(1), an Israeli enemy patrol consisting of around 40 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 0915 hours.
	0900	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, installing an approximately 200-metre barbed wire (concertina) strip. The work ended at 1700 hours.
	0900	In occupied Palestinian territory, opposite the town of Kafr Kila near point B82, an Israeli enemy patrol consisting of 10 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 0955 hours.
	0945	In occupied Palestinian territory, opposite the town of Wazzani, at the Humayri position, an Israeli enemy group consisting of 25 soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1025 hours.
17 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Alma al-Sha'b, 21 in Yarun, 20 in Marwahin, 14 in Duhayrah, 14 in Amra and 13 in Markaba.
	0900	In occupied Palestinian territory opposite the town of Markaba, an Israeli enemy Merkava tank approached. It positioned itself behind the earthen berm and pointed its cannon in the direction of Lebanese territory. It left in the direction of occupied territory at 1010 hours.
	1100	In occupied Palestinian territory, opposite the town of Wazzani at the Humayri position, an Israeli enemy patrol consisting of 10 soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1130 hours.
18 March	0800	In the occupied town of Ghajar, a trench digger, a civilian jeep, a wheeled bulldozer and four Israeli enemy workers approached. They dug 15 holes and placed metal pipes inside. A truck loaded with basecourse also approached. It unloaded it at the location and a steamroller levelled the road. The work ended at 1615 hours.

	0930	In the area around the occupied town of Ghajar, opposite the United Nations Interim Force in Lebanon (UNIFIL) Spanish contingent's position 28-4, Israeli enemy personnel finished their reinforcement of the technical fence, installing a barbed wire (concertina) strip. The work ended at 1630 hours.
19 March	1130	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of four soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1215 hours.
20 March	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 10 soldiers in military uniform approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon five patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1100	In occupied Palestinian territory, near point TP36(2), an Israeli enemy Merkava tank approached. It pointed its cannon in the direction of Lebanese territory until 1340 hours.
21 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Yarun, 6 in Duhayrah, 8 in Markaba, 6 in Amra and 1 in Hula.
	0800	Inside the occupied town of Ghajar, an Israeli enemy wheeled bulldozer, two steamrollers, four trucks and a water tanker approached. They laid and levelled basecourse on the dirt road. The work ended at 1710 hours.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 soldiers in military uniform approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon five patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory.
22 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 22 in Yarun, 4 in Marwahin, 8 in Duhayrah and 26 in Amra.
	0930	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished their reinforcement of the technical fence, installing a 100-metre barbed wire (concertina) strip and affixing metal pegs with cement.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 soldiers in military uniform approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon five patrol members took up positions inside the emplacement situated at the site, while the other eight took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0900 hours, a Merkava tank approached. It pointed its cannon in the direction of Lebanese territory until 1700 hours.
	1020	In the occupied Shab'a Farms, Israeli enemy soldiers conducted an artillery drill until 1500 hours.

	–	Israeli enemy soldiers fired five flares over the Radar position in the occupied Shab‘a Farms between 2200 hours and 2245 hours.
23 March	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished their reinforcement of the technical fence, installing a barbed wire (concertina) strip and affixing metal pegs with cement.
24 March	1730	Inside occupied Lebanese territory opposite Ra’s al-Naqurah, six Israeli enemy soldiers carried out a foot patrol between points B1 and M1 until 1815 hours.
27 March	0830	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, five Israeli enemy personnel finished their reinforcement of the technical fence, installing metal rods along the dirt road. A steamroller also levelled previously laid basecourse. The work ended at 1700 hours.
	1000	Several bursts of automatic-weapons fire were heard coming from the occupied Shab‘a Farms in the area around the Israeli enemy Ramta position, lasting until 1015 hours.
	1230	In occupied Palestinian territory, opposite the town of Markaba in the area around point B75, an Israeli enemy Defender vehicle approached. Three soldiers disembarked, took up combat positions, and pointed their weapons towards Lebanese territory. They left in the direction of occupied territory at 1300 hours.
	1500	Several bursts of medium- and light-weapons fire were heard from inside the occupied Shab‘a Farms in the area around the Summaqah position, lasting until 1520 hours.
28 March	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel poured concrete alongside the dirt road and set up a barbed wire strip at the location. The work ended at 1700 hours.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 11 soldiers in military uniform approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon five patrol members took up positions inside the emplacement situated at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0900 hours, a Merkava tank approached. It pointed its cannon in the direction of Lebanese territory until 1645 hours.
	0845	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of five soldiers in military uniform approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 0900 hours.
	0950	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, an Israeli enemy group consisting of 70 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1045 hours.
	1045	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy patrol consisting of 30 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1200 hours.

29 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 34 in Yarun, 27 in Marwahin, 8 in Duhayrah and 14 in Markaba 45 in Amra.
	0745	In occupied Lebanese territory, opposite Ra's al-Naqurah east of point M1(1), eight workers in civilian clothing approached, escorted by three Israeli enemy soldiers in military uniform. They crossed the metal separation fence through the pedestrian gate and set up an approximately five-metre barbed wire (concertina) strip on the northern side of the aforementioned fence. The enemy personnel left in the direction of occupied territory at 1015 hours.
	0900	In occupied Palestinian territory, in the area around point TP36(2), a Merkava tank approached. It pointed its cannon in the direction of Lebanese territory until 1220 hours.
	1300	In the occupied Shab'a Farms at Bastarah, opposite the Israeli enemy Zabdin position near the concrete blocks, an Israeli enemy patrol consisting of a Defender vehicle, a Merkava tank, a D9 bulldozer and 25 soldiers approached. The soldiers took up combat positions and the tank pointed its cannon and the soldiers their weapons in the direction of personnel of a Lebanese army patrol and a UNIFIL patrol located on the Lebanese side. The enemy patrol left in the direction of the aforementioned position at 1330 hours.
30 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Mays al-Jabal, 13 in Alma al-Sha'b, 40 in Yarun, 6 in Duhayrah, 11 in Markaba and 2 in Mays al-Jabal.
	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, installing 25 metal pipes alongside the dirt road and attaching metal netting. The work ended at 1715 hours.
	1005	The sound of light automatic-weapons fire was heard coming from the occupied Shab'a Farms in the area around the Israeli enemy Zabdin position, lasting until 1030 hours.
31 March	–	Landmines left behind by the Israeli enemy were detonated as follows: 32 in Yarun, 18 in Marwahin, 25 in Duhayrah, 47 Amra, 16 in Markaba, 8 in Mays al-Jabal and 12 in Alma al-Sha'b.
	0330	In occupied Palestinian territory, opposite the town of Kafr Kila at the Israeli enemy Jabal al-Tayyarah position, an Israeli enemy group consisting of 80 individuals in civilian clothing approached. They scouted the area and took pictures of the Lebanese side. They left in the direction of occupied territory at 1045 hours.
	0800	To the north of the occupied town of Ghajar, opposite liberated Lebanese territory, on the SD1 road, Israeli enemy personnel finished work on the technical fence, installing 20 metal pipes alongside the dirt road and attaching metal netting. The work ended at 1410 hours.
	1900	In occupied Lebanese territory opposite Ra's al-Naqurah, six Israeli enemy soldiers in military uniform conducted a foot patrol from west of point M2 point to the area around point M1(1) south of the metal separation fence opposite Ra's al-Naqurah. They left from opposite point M2 in the direction of occupied Palestinian territory at 1920 hours.

2 March	0435	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> of 1 October 2011 for 15 minutes, proceeding on its way for some 407 m. Crew members directed a searchlight towards Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	0440	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 10 minutes, proceeding on its way for some 150 m. A Lebanese fishing boat happened to be in Lebanese territorial waters at the time. The crew of the hostile vessel directed a searchlight at it, broadcast in Hebrew over loudspeakers and sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	0640	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for five minutes, proceeding on its way for some 50 m. Crew members sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
5 March	0452	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 10 minutes, proceeding on its way for some 464 m. Crew members directed a searchlight towards Lebanese territorial waters for two minutes, sounded warning sirens and broadcast in Hebrew. The launch then left in the direction of occupied Palestinian territorial waters.
	1050	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 25 minutes, proceeding on its way for some 500 m. Crew members sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	1835	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for nine minutes, proceeding on its way for some 481 m. Crew members directed a searchlight towards Lebanese territorial waters for two minutes. The launch then left in the direction of occupied Palestinian territorial waters.
	1908	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 10 minutes, proceeding on its way for some 389 m. Crew members directed a searchlight towards Lebanese territorial waters for two minutes. The launch then left in the direction of occupied Palestinian territorial waters.
	2040	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 1 hour and 25 minutes, proceeding on its way for some 407 m. The launch then left in the direction of occupied Palestinian territorial waters.
	2216	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for five minutes, proceeding on its way for some 240 m. The launch then left in the direction of occupied Palestinian territorial waters.

8 March	0030	From inside occupied Palestinian territorial waters off Ra's al-Naqurah, crew members of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a period of two minutes.
	1235	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 10 minutes, proceeding on its way for some 537 m. Crew members sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	2340	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 15 minutes, proceeding on its way for some 407 m. Crew members directed a searchlight towards Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
9 March	1630	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 20 minutes, proceeding on its way for some 222 m. Crew members sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	1908	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 10 minutes, proceeding on its way for some 389 m. The launch then left in the direction of occupied Palestinian territorial waters.
	2040	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. <a href="#">6433 (2011)</a> for 25 minutes, proceeding on its way for some 407 m. The launch then left in the direction of occupied Palestinian territorial waters.
