Security Council Seventy-seventh year

Letter dated 13 December 2022 from the Permanent Representative of Cyprus to the United Nations addressed to the Secretary-General

Upon instructions from my Government, I enclose herewith sixteen annexes recording the violations of Cyprus' national airspace, of international air traffic regulations in Cyprus' flight information region and of the territorial waters of Cyprus, and the illegal use of closed ports and airports in Cyprus, by the air and naval forces of Turkey, during the months of January, February, March, April, May, June, July and August 2022 (see annexes I–XVI).

A total of 560 air and 33 naval violations were observed during this eight-month period. It should be noted that 73 out of the 560 air violations were related to the use of Turkish military uncrewed aerial vehicles. Turkey's actions are at variance with fundamental provisions of the Chicago Convention as well as the International Civil Aviation Organization annexes, thus causing potential risks for international air navigation.

Furthermore, it should be noted that two incidents of Turkish aggression in Cyprus' Exclusive Economic Zone took place at the beginning of 2022: on 15 and 20 January, Turkish frigates harassed and prevented the vessel "NAUTICAL GEO" from carrying out surveys licensed by the competent authorities of the Republic of Cyprus.

Turkey's persistently aggressive behaviour on the ground is evidenced by its constant violations of the military status quo on the island and near-daily incursions into the buffer zone, compounded by the continuous upgrading of its military infrastructure, in the already densely militarized occupied areas of Cyprus. Restrictions on the movement of the United Nations Peacekeeping Force in Cyprus have escalated to open threats to remove the United Nations peacekeeping operation's presence from the occupied areas, as publicly expressed by the secessionist regime. Such open declarations of intentions to violate Security Council resolutions by interfering with the status and deployment of the peacekeeping force in Cyprus should be stymied accordingly. The United Nations must make it abundantly clear that it cannot be intimidated into entertaining radical threats, especially when these stem from illegal occupying forces, or risk its very integrity in the process.





The unlawful Turkish provocations in Varosha continue unabated, despite the clear call by the Security Council (S/PRST/2021/13) upon the Turkish side to stop and reverse the violations of the status quo in the fenced area. Turkey and its subordinate local administration have, in this respect, also publicly stated their intentions to exploit the area for their own benefit, in total disregard for Security Council resolution 550 (1985), which calls for the return of Varosha to its lawful inhabitants and the transfer of the area to the administration of the United Nations.

The belligerent rhetoric of Turkey further adds to its destabilizing actions on the ground in Cyprus and the wider region. In its effort to impose a "two-State solution" on the island, Turkey follows an a-la-carte approach to Security Council resolutions, branding these as obsolete when they do not fit its discourse and calling upon the international community to "face the realities on the ground".

The "realities on the ground" are in fact evident in the situation that Turkey has created in Cyprus, through the use of force, in violation of Article 2 of the Charter of the United Nations, and the continuous military occupation of a third of the territory of the Republic of Cyprus; in the unceasing violations of human rights and international legality; and in the barbed wire that has been marring the landscape of Cyprus for decades. In this context, Turkey provocatively demands that the international community recognize changes born of aggression, in line with the defunct doctrine of the right of conquest, and openly declares that she will continue violating Security Council resolutions, in total disregard of Article 25 of the Charter.

While, over the last year, the international community has rightly rallied in defence of the Charter of the United Nations, it is imperative for the United Nations to demonstrate that there are no double standards in the application of the Charter. In a public statement last October, the Under-Secretary-General, Rosemary Di Carlo, affirmed that "unilateral actions aimed to provide a veneer of legitimacy to the attempted acquisition by force by one State of another State's territory, while claiming to represent the will of the people, cannot be regarded as legal under international law".

Turkey's actions since 1974 are a violation of the territorial integrity and sovereignty of Cyprus and by consequence of the Charter of the United Nations. The sovereignty and territorial integrity of States under attack must be defended, no matter where the attacks are coming from or how much time has passed. The Security Council must stand behind its resolutions and ensure that they have meaning; otherwise, we risk undermining the credibility of the international system.

Despite the stumbling blocks placed before us by Turkey and its subordinate local administration, the Republic of Cyprus remains committed to a settlement as defined in Security Council resolutions: one based on a bizonal, bicommunal federation, with political equality. In that regard, we continue to be encouraged by your messages of persistence and determination in the efforts for the resumption of formal negotiations.

I should be grateful if you would circulate the present letter and its annexes as a document of the General Assembly, under agenda item 38, and of the Security Council.
