Annotations to the agenda

1. Adoption of the agenda and organization of work

The Committee, at its third session (New York, 17-28 January 1994), approved the provisional agenda for the fourth session, as contained in decision 3/2 of the Report of the Third Session (A/49/84).

The provisional agenda for the fourth meeting is submitted for adoption.

The Plenary will hear statements from ministerial representatives of INCD Member countries, Heads of UN Agencies and the Chairman of the Committee. After these statements, the Executive Secretary of the INCD Secretariat will introduce the Secretariat documents A/AC.241/15/Rev.1, the revised negotiating text of the Convention, and A/AC.241/19, the negotiating text of the regional implementation annex for Africa.

The provisional work programme (Annex I) provides further details on the organization of work to be undertaken by the Committee. The proposed schedule for the deliberations of the two working groups generally follows the order of the section of document A/AC.241/15/Rev.1. Discussion in Working Group II on the African annex will proceed through the draft articles in document A/AC.241/19.

The Committee might have to consider an additional list/s of Non-Governmental Organizations (NGOs) recommended for accreditation for the negotiating process of the Convention.

2. <u>Elaboration of an international convention to combat desertification in countries experiencing serious drought and/or desertification, particularly in Africa</u>

The Committee will have before it two documents. Document A/AC.241/15/Rev.1 represents the state of negotiations on the Convention at the end of the Committee's third session. At the same session, the Committee requested the Secretariat to prepare the negotiating text of a regional implementation annex for Africa contained in document A/AC.241/19.

3. Review of the situation as regards extrabudgetary funds

- (a) Special Voluntary Fund to support the participation of developing countries affected by drought and desertification, particularly in the least developed countries
 - (b) Trust Fund for the negotiating process

The Committee will have before it the document (A/AC.241/20) submitted by the Secretariat indicating the present status of the two funds.

4. Adoption of the provisional agenda for the final session

The Committee will have before it a note by the Secretariat on the draft provisional agenda for its final session.

5. Adoption of the report of the Committee on its fourth session

The Committee will adopt a report on its fourth session.
