#### ADOPTION OF THE AGENDA AND ORGANIZATION OF WORK

#### Programme of Work

### 1. Consideration by Plenary

The plenary will begin consideration of this item at its session in the afternoon of 13 September, continuing through the morning of 14 September. It will hear statements from ministerial representatives of INCD member countries, Heads of UN agencies and the Chairman of the Committee. After these statements, the Executive Secretary of the INCD will introduce the Secretariat document (A/AC.241/12) which compiles proposals for the text of The Convention as submitted by governments as well as those made during the Committee's first substantive session. Representatives of non-governmental organisations (NGOs) will then report to the Committee on the results of the International NGO forum held in Bamako, Mali 16 - 20 August 1993, which considered the contents of The Convention and the role of NGOS in it.

Initial plenary discussion of this item will conclude on the morning of 14 September. Working Groups I and II will take it up through 23 September with a brief progress report to the plenary on the morning of 20 September. The plenary will consider the reports of the two working groups on 24 September.
