## Pattern of Conferences

## Report by the Secretary-General

1. Under paragraph 3 of the resolution relating to the Pattern of Conferences adopted on 13 December 1957, the General Assembly
"Requests the Secretary-General to submit to the General Assembly every year a basic programme of Conferences for the following year established in conformity with the present pattern and after consultation, as appropriate, with the organs concerned."
2. In the annex hereto is set out the basic programme of meetings for 1959 as scheduled at 17 October 1958. Accordingly, the prograrme submitted herewith is to some extent tentative; it is the intention of the Secretary-General to issue an addendum to the present report at a later date this year.
3. The present report does not include provision for the convening of certain commodity conferences; while the Secretary-General foresees the need for convening, during 1959, several conferences dealing with specific commodity problems, including a Negotiating Conference for a New Wheat Agreement, the programme of these particular meetings is not as yet determined. To the extent possible, the necessary budgetary provision for known conferences could be included in the 1959 estimates. It is therefore the Secretary-General's intention to submit such estimates to the current session of the General Assembly.
