Li Nan (China)

Born in Jinan, Shandong Province, in February 1973.

Ms. Li Nan is a counselor of the Department of International Organizations and Conferences, Ministry of Foreign Affairs of the People's Republic of China. She has been working in foreign service since 1995 with extensive experience in multilateral diplomacy, mainly related to the United Nations affairs.

Ms. Li started her career in the field of human rights, attending sessions and meetings of a wide range of UN Human Rights bodies, conducting dialogues and cooperation with the UN and its member states. This has greatly contributed to her mastery of working with the UN mechanisms and provided her with a strong awareness of human rights in her entire career.

From 2004 to 2007, Ms. Li served as personal assistant to Mme. QIN Xiaomei, the first Chinese expert to the UN Permanent Forum on Indigenous Issues (UNPFII). She had a great opportunity of following the UN process pertaining to the protection of the rights of indigenous peoples. She also accompanied Mme. QIN on her field trips with the group of experts to the indigenous land in Denmark, Russian Federation and Mexico, where she has gained first-hand understanding of indigenous issues. In

March 2007, Ms. Li helped Mme. QIN, on behalf of the Ministry of Foreign Affairs of China, organize the Pre-sessional meeting of the 6th Session of the UNPFII.

Ms. Li also worked for three years with the United Nations Association of China, the first NGO in China which was granted general consultative status with the United Nations Economic and Social Council. During that period, she worked closely and extensively with youth organizations, academia and press from home and abroad. Ms. Li's experience as a diplomat and once an NGO officer may make her easily fit in a UN body where strong collaboration is needed between governments and civil organizations, such as UNPFII.

Sara Omi Casama is a member of the indigenous Emberá people and a lawyer who has specialized in human rights and protection mechanisms.

She has shown leadership since her adolescence and counts among her most significant contributions her positions as a traditional authority, as president of the Emberá General Congress of Alto Bayano and her work at UN-Women and at the Office of the Ombudsman in Panama. She has always focused on indigenous peoples, especially youth and indigenous women.

She served as a spokeswoman for indigenous women at the United Nations Climate Change Conference, participating at the Fifteenth Conference of the Parties in Denmark, the Twentieth Conference of the Parties in Peru, the Twenty-second Conference of the Parties in Morocco, the Twenty-fifth Conference of the Parties in Chile and Spain and the Twenty-sixth Conference of the Parties in the United Kingdom.

She is president of the Coordinadora de Mujeres Líderes Territoriales de Mesoamérica (Coordinator of Territorial Women Leaders of Meso-America), a platform for political dialogue between women of the territories represented in the Meso-American Alliance of Peoples and Forests; an adviser to the Asociación de Mujeres Artesanas Emberá (Association of Emberá Craftswomen); a member of the enterprise "Jumara Juwa", which in the Emberá language means the hands of all women; a member of the board of directors and secretary of the Organización de la Mujeres Unidas por la Biodiversidad (Organization of Women United for Biodiversity).

Luis Alberto Pachala Poma (Ecuador)

[Original: English/Spanish]

Mr. Pachala is a kichwa-waranka politician and founder of the Inclusive, Active, Responsible and Innovative Society (SIARI) movement. In alliance with the CREO political party, he was elected as a congressman representing the province of Bolivar, and later, he became block chief of the CREO-SIARI-AMAUTA movement at the National Assembly of Ecuador.

Pachala was born in Paltabamba, province of Bolívar on November 10, 1970. He holds B.A. in Science in Education, a B.A. in Economy, and a Master's degree in Business Administration. Pachala defines himself as a man of the countryside with big dreams, close to the service of the Ecuadorian people.

As part of his professional life, he was a professor of secondary and higher education, and the dean of the Faculty of Social Sciences at the Metropolitan University of Ecuador. Pachala has held public positions as Undersecretary of the Ministry of Social Welfare, Minister of Social Welfare, Minister and Vice Minister of Agriculture; from where he has influenced the quality of life of Ecuadorians, delivering public works and projects throughout the country.

In 2007 he was elected as a deputy of the Republic of Ecuador for the province of Bolivar, and later, he became President of the Commission for Indigenous Affairs and other Ethnic Groups of the Ecuadorian parliament. He was also a member of the Commission for Human Rights of Indigenous Peoples of the Indigenous Parliament of America.

In 2008 he was an advisor and political and social consultant for the Kokopelia Asesores Company, and in 2009 he became an advisor at the National Assembly of Ecuador. From 2010 to 2015, through merit and opposition, he became one of the seven councilors of the first Council for Citizen Participation and Social Control in Ecuador.

In 2016 he created the Inclusive, Active, Responsible and Innovative Society (SIARI) movement, which holds a humanistic, pragmatic, and progressive vision whose motto is "a seed, a hope, and a single fist."

In 2017, Pachala was elected as a congressman representing the province of Bolivar and he is currently the Minister for the Development of Indigenous and Black Peoples, a position from which he has managed to give institutionalism to the indigenous, montubio and black peoples of Ecuador and has articulated solutions for their needs.
