^{*a*} Beginning in 2020, the strategic framework and proposed programme of work are subject to the new annual programme budget approved by the General Assembly in its resolution 72/266 A, including a new results framework. A draft of the new results framework was proposed in annex III to the report of the Secretary-General entitled "Shifting the management paradigm in the United Nations: improving and streamlining the programme planning and budgeting process" (A/72/492/Add.1). The preparation of the 2020 annual programme budget is scheduled to be finalized in the first quarter of 2019.
