In accordance with Article 21 of the Convention of 1931 for limiting the Manufacture and regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to forward to the Members of the United Nations and to the other parties to the Convention the following text communicated by the Government of Sweden.

ROYAL BOARD OF HEALTH ORDER

(To be filed with the statutes kept in pharmacies)

Amending certain portions of the Board's Order of 20 May 1947 (M.F. Ser. A No. 75) on the prescription and supply of medicaments by pharmacies etc.:

11 February 1948.

The Board of Health has seen fit to order, first, that Article 42 (c) of the Board's Order of 20 May 1947 on the prescription and supply of medicaments by pharmacies etc. be cancelled, and, secondly, that Article 45 of that Order be amended as hereinafter shown:

Supply of certain medicaments in portioned doses

45. The medicamentshalf the maximum dose only.

These provisions also apply to caffeine, but doses may not exceed 0.1 gramme.

This Order shall come into force on 1 April 1948.

ROYAL BOARD OF HEALTH ORDER

(To be filed with the statutes kept in pharmacies)

Amending the wording of Article 26 of the Board's Order of 20 May 1947 (M.F. Ser. A No. 75) on the prescription and supply of medicaments by pharmacies etc.:

18 August 1948.

Whereas the Central Board of Education in consultation with the Board of Health issued regulations on 19 June 1948 for the keeping and distribution of medicaments in institutions for the blind, and in deaf and dumb schools, nomad schools, school homes and workshop schools, the Board of Health has seen fit to order that Article 26 of the Board of Health Order of 20 May 1947 on the prescription and supply of medicaments by pharmacies etc. be amended as hereinafter shown:

Special labelling of certain medicaments dispensed for medical institutions 26. The following provision shall apply to the dispensing of medicaments to medical institutions or similar consumers (district dental clinics, central dental clinics or any other general clinic for public dental treatment, institutions for the aged, homes for the destitute, nursing homes, workhouses, children's homes, schoolchildren's holiday camps, guardianship schools, hospitals for the insane or mentally defective, institutions for treatment of epileptics and of consumptives, institutions for the blind, deaf and dumb schools, nomad school-homes, other school-homes, workshop schools, etc.): in addition to the general provisions applicable to the dispensing of medicines, each package of medicine shall bear the date of dispensing and also, if it is composed of poison of Class I, the designation "Group I."

This Order shall come into force immediately.
