
Introduction

Due to restrictions associated with the coronavirus disease (COVID-19) pandemic and the availability of facilities for remote interpretation, the twenty-fifth meeting of the Working Group of the Parties to the Convention on Access to Information, Public Participation in Decision-Making and Access to Justice in Environmental Matters (Aarhus Convention) will be held in two slots: (a) items of an informational nature will be considered in an online format on 3 May 2021, with no decision-making except the adoption of the agenda for the meeting; and (b) items requiring decision-making will be considered on 7 and 8 June 2021 in a hybrid format (combining online and in-person participation). The draft outcomes of the first slot will be presented to the Working Group for consideration and adoption during the second slot of the meeting.
