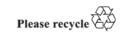

II. Annotations

1. Adoption of the agenda

The Group of Experts towards Unified Railway Law (Group of Experts) will be invited to adopt the session's agenda.

2. Execution of the Mandate of the Group of Experts

The Group of Experts adopted its workplan containing detailed action plan at the seventeenth session (Geneva, 9-11 July 2018). In accordance with this workplan and further to the decisions taken at the nineteenth session, the Group of Experts is expected to further advance its work on specific tasks, as follows:

(a) Monitoring of the finalization of necessary documents:

The Group of Experts agreed at its nineteenth session that ECE/TRANS/SC.2/GEURL/2019/3 which contains a list of documents on the contract of carriage which may require adjustments to the provisions of URL should be updated by adding information on: (i) the relevance of a specific document in use under CIM/SMGS systems to the draft URL provisions and; (ii) necessary modification, if any, to each document of URL relevance. To this end, the secretariat supported by PKP Cargo S.A. will present ECE/TRANS/SC.2/GEURL/2019/9 which provides the requested information.

The Group of Experts will be invited to consider ECE/TRANS/SC.2/GEURL/2019/9 and agree on the next steps in updating or adjusting the documents.

The secretariat will report on the review of the translation in English and French of the ad-hoc consignment note by CIT and on the availability of the English and/or French templates of the consignment note.

(b) Monitoring of performance of a substantial number of real pilot tests:

The Group of Experts requested the secretariat at its nineteenth session to collect the views of the railway undertakings as to possible changes to the ad hoc consignment note regarding issues raised during that session and provided in ECE/TRANS/SC.2/GEURL/2019/2, point III.6 (b) (vii). The secretariat will report on its communication with the railway undertakings and on the views collected.

The Group of Experts will be invited to consider the information provided and agree on possible changes to the ad hoc consignment note.

Experts will be then invited to inform about pilot tests organized after the nineteenth session and about findings from these tests, when applicable on testing the URL provisions on liability.

The Group of Experts will be invited to consider findings from the additional tests.

(c) Scope of URL and its conversion into a legally-binding instrument:

The Group of Experts is expected to conclude on its approach to developing URL as a legally-binding instrument. After discussing at the nineteenth session ECE/TRANS/SC.2/GEURL/2019/5 which provides impact analysis and the benefits from adopting the convention on contract of carriage of goods by railway in international traffic as URL legally-binding instrument, the Group is expected to consider ECE/TRANS/SC.2/GEURL/2019/12, which should: (i) describe the various railway issues to be covered through the URL framework convention; (ii) analyse the impact of the URL framework convention and its benefits; and

(iii) propose the management system for the URL framework convention. This document is to be submitted by the Russian Federation.

The Group of Experts is also expected to agree on the draft text for preamble and final provisions for URL as a legally-binding instrument. To this end, and in view of the approach concluded, the Group will consider ECE/TRANS/SC.2/GEURL/2019/10 and ECE/TRANS/SC.2/GEURL/2019/11, prepared by the secretariat, and containing proposed text for respectively the preamble and the final provisions.

Finally, in view of the approach concluded for developing URL as a legally-binding instrument, the Group of Experts will be invited to discuss railway issues that should be analysed as to whether it would be beneficial to cover them in URL.
