Annex V

Glossary of terms

This section will provide definitions of key terms used in the document. The definitions below are provided for illustrative purposes.

<i>Term</i>	<i>Definition</i>
Earmarked contributions	Contributions made or reimbursed for specific services or activities. Such contributions may not be used for purposes other than those for which they were provided without prior authorization by the donor.
Unearmarked contributions	Contributions given as general support and not restricted in use in any way.
Conference of the Parties (COP)	The supreme decision-making body of the Convention. All Parties to the Convention are represented at the sessions of the COP, at which they review progress in the implementation of the Convention and other legal instruments under the Convention, and take decisions to promote the effective implementation of the Convention, including with regard to institutional and administrative arrangements.
Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP)	The decision-making body of the Kyoto Protocol. All Parties to the Kyoto Protocol are represented at the sessions of the CMP; States that are not Parties participate as observers. The CMP reviews progress in the implementation of the Kyoto Protocol and takes decisions to advance it.
Subsidiary Body for Implementation (SBI)	One of two permanent subsidiary bodies of the COP. It supports the work of the decision-making bodies through the review of the effective implementation of the Convention and the Kyoto Protocol. A particularly important task in this respect is examining the information in the national communications and emission inventories submitted by Parties in order to assess the Convention's overall effectiveness. The SBI also reviews the financial assistance given to Parties not included in Annex I to the Convention to help them implement their commitments under the Convention, and provides advice to the COP on guidance to the operating entities of the Financial Mechanism. The SBI also advises the COP on budgetary and administrative matters.
Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA)	The decision-making body of the Paris Agreement. All Parties to the Paris Agreement are represented at the sessions of the CMA, while States that are not Parties participate as observers. The CMA oversees the implementation of the Paris Agreement and takes decisions to advance it.
Bureau of the COP	It supports the COP, the CMA and the CMP through the provision of advice and guidance regarding the ongoing work under the Convention, the Paris Agreement and the Kyoto Protocol, the organization of their sessions and the operation of the secretariat, especially at times when the COP, the CMA and the CMP are not in session. The Bureau is elected from representatives of Parties nominated by each of the five United Nations regional groups and by small island developing States. The Bureau is mainly responsible for questions of process management. It provides advice to the President of the COP and assistance in various tasks (e.g. members of the Bureau undertake consultations on behalf of the President). The Bureau is responsible for examining the credentials of Parties, reviewing the list of intergovernmental and non-governmental organizations seeking admission as observers, and submitting a report thereon to the COP.
Trust Fund for the Core Budget of the UNFCCC	Fund financed from indicative contributions (or general purpose contributions from donors) and supports the core functions of the secretariat.

Trust Fund for Participation in the UNFCCC Process	Fund financed from voluntary contributions and supports participation of representatives of eligible developing country Parties and Parties with economies in transition in the sessions of the COP and its subsidiary bodies.
Trust Fund for Supplementary Activities	Fund financed from voluntary contributions and supports mandated activities for which provisions are not made under the core budget of the UNFCCC.
Trust Fund for the Clean Development Mechanism (CDM)	Fund financed from fees charged for the registration of clean development projects and supports the administration of the CDM, which allows Parties to generate certified emission reductions that they can use towards their emission limitation and reduction commitments.
Trust Fund for the International Transaction Log (ITL)	Fund financed from indicative contributions (or general purpose contributions from donors). The purpose of the ITL is verifying the validity of transactions between the national registries of Parties included in Annex B to the Kyoto Protocol and the CDM registry.
Trust Fund for the Special Annual Contribution from the Government of Germany	Fund financed from a voluntary contribution from the Host Government of the secretariat. It is used to finance logistical arrangements of UNFCCC events taking place in Bonn, Germany, including workshops and arrangements for sessions of the subsidiary bodies.
Special account for programme support costs	Account funded from charges made to the activities financed from indicative and voluntary contributions as well as fee-financed activities.
Special account for conferences and other recoverable costs	Account funded from voluntary contributions. The funds are used to cover the costs associated with the hosting of the sessions of the COP under the Host Country Agreement.
Category of expenditure	Category in the programme/organizational structure for which budgets are allocated and utilized.
