Monday, 28 May 2012

Rif Dimashq governorate

- 1. At 2200 hours on 27 May 2012, an armed terrorist group detonated noise bombs in various locations in the city of Kiswah to terrorize the population.
- 2. At 0230 hours, an armed terrorist group detonated a car bomb at a law enforcement checkpoint near the Malihah turn-off, killing Lieutenant Qusayy Kahilah and Staff Sergeant Khalid al-Amouri and wounding Colonel Maan Kanaan.
- 3. At 0700 hours, an armed terrorist group detonated a car bomb at a law enforcement checkpoint in the Malihah district, wounding four personnel.
- 4. At 0900 hours, an armed terrorist group opened fire on law enforcement personnel in Yabrud, killing Captain Nidal Mansour and wounding three.
- 5. At 1100 hours, an armed terrorist group ambushed an ambulance carrying wounded law enforcement personnel in the district of Zabadani, killing conscript Hussein al-Talab and wounding four, including Lieutenant Ali al-Jasim.
- 6. At 1200 hours, an armed terrorist group deployed on the highway in the Tall Manin district and terrorized the population.
- 7. At 1400 hours, an armed terrorist group smashed shops, burned vehicles and set fire to the municipality building in the town of Babila.
- 8. In the town of Kafr Batna, three unidentified bodies were found thrown into the river.
- 9. In the town of Babila, an explosive device inside a tire was detonated, wounding five law enforcement personnel.
- 10. In the town of Kiswah, an armed terrorist group shot and abducted Brigadier Muhammad Taysir Ahmad al-Tarshan as he was driving his car, accompanied by conscript Muhammad Abdo Zakariya al-Tarshan, who was taken to the Salam hospital in Darayya after being shot.
- 11. Two unidentified, decomposing bodies were found in the town of Jisrayn.
- 12. In the town of Hajr al-Aswad, an explosive device was discovered, planted beside the door of Hajr al-Aswad first school; the device was detonated by military engineers.
- 13. In 'Aqraba, armed men forced shop owners to close their premises, threatening to set fire to them.
- 14. In Tall, armed men forced shop owners to close their premises, threatening to set fire to them.

- 15. In Hajr al-Aswad, armed men forced shop owners to close their premises, threatening to set fire to them.
- 16. In Malihah, armed men forced shop owners to close their premises by threatening to set fire to them.

Damascus governorate

- 17. At 2330 hours on 27 May 2012, an armed terrorist group opened fire from in between residential buildings in the direction of Mazzah airport.
- 18. In Maydan and Nahr 'Eisheh, armed men forced shop owners to close their premises by threatening to set fire to them.
- 19. In Bab Sarijah, Shuwaykah and Qabr 'Atikah, armed men forced shop owners to close their premises by threatening to set fire to them.
- 20. In Hamidiyah and Bab Musalla, armed men forced shop owners to close their premises by threatening to set fire to them.
- 21. In Hariqah and Rukn al-Din, armed men forced shop owners to close their premises by threatening to set fire to them.

Dar'a governorate

- 22. At 2030 hours on 27 May 2012, an armed terrorist group broke into and searched the home of Party group secretary, Madin Mahamid, abducting him.
- 23. At 2100 hours on 27 May 2012, an armed terrorist group broke into the Iyab lower secondary school and ransacked it.
- 24. At 2130 hours on 27 May 2012, an armed terrorist group opened fire on the law enforcement forces checkpoint at Sadd, wounding four personnel, including Lieutenant Raid Muhaimid.
- 25. At 2130 hours on 27 May 2012, an armed terrorist group wounded Colonel Said al-Miqdad in Busra al-Sham, while attempting to abduct him.
- 26. At 2130 hours on 27 May 2012, an armed terrorist group abducted Chief Warrant Officer Adnan al-Miqdad in Busra al-Sham.
- 27. At 2200 hours on 27 May 2012, an armed terrorist group broke into the second suburban district lower secondary school in the city of Dar'a and ransacked it.
- 28. At 2230 hours on 27 May 2012, an armed terrorist group broke into the Banat al-Sadd lower secondary school in the city of Dar'a.
- 29. At 0100 hours, an armed terrorist group opened fire on most of the law enforcement checkpoints in Dar'a.
- 30. At 0150 hours, an armed terrorist group opened fire on law enforcement checkpoints in the town of Karnaz (the Qaws checkpoint, guard post checkpoint, Omari mosque checkpoint and Habariyah road checkpoint); one member of the law enforcement forces was wounded.
- 31. At 0600 hours, an armed terrorist group abducted citizen Ahmad al-Zibi between the villages of Darah and East Malihah, as he was on his way to his agricultural project.

- 32. At 0700 hours, an armed terrorist group abducted and killed a Syrian Palestinian, Muhammad Awadh.
- 33. At 0900 hours, an armed terrorist group broke into the school in the town of Muzayrib and removed the students from the examinations by force of arms.
- 34. At 1000 hours, an armed terrorist group detonated an explosive device and opened fire on law enforcement checkpoints in the city of Da'il, killing conscript Fadi Junayd Haj Ahmad and wounding four personnel, including Lieutenant Sumer Abbas.
- 35. At 1000 hours, an armed terrorist group threatened to kill cleaning workers in Azra', West Masikah.
- 36. At 1830 hours, an armed terrorist group attacked the home of Mayor Ahmad al-Eid in Inkhil, wounding him.
- 37. Armed men set an ambush in the town of Saham al-Jawlan to terrorize the population and stop them from going to work.
- 38. Unidentified armed men opened fire on the Mismiyah subdistrict administrative building and law enforcement checkpoints.
- 39. Unidentified armed men opened fire on the Mukhayyam police station and the adjacent law enforcement checkpoint.
- 40. Four unidentified bodies were found beside the dam on the East Karak road; they had been buried haphazardly and partially eaten by wild animals.
- 41. Lieutenant Bashar Ahd Sulayman was taken to Dar'a national hospital with shrapnel wounds all over his body caused by an explosive device detonated at a law enforcement and security forces checkpoint in the city of Da'il. Furthermore, an armed terrorist gang attacked military checkpoints, wounding a number of soldiers, who were taken to hospital.
- 42. Unidentified armed men opened fire on a law enforcement and security forces checkpoint in Da'il, wounding an officer and three men, who were admitted to the Sanamayn military hospital.

Homs governorate

- 43. At 1900 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in the Bayyadah district.
- 44. At 2000 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel near the Rizq Saloum school, from the direction of the Khidr district.
- 45. At 2000 hours on 27 May 2012, an armed terrorist group launched four rocket-propelled grenades at law enforcement personnel near the Bab Tadmur roundabout, from the direction of the Warshah and Khalidiyah districts.
- 46. At 2200 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in the district of Hulah.
- 47. At 2215 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in the Qusur district, wounding one.

- 48. At 2230 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in Jabb al-Jandali, from the direction of the Warshah and Bab al-Durayb districts.
- 49. At 2400 hours, an armed terrorist group opened fire on law enforcement personnel near the Makatib roundabout.
- 50. At 2400 hours, an armed terrorist group opened fire on law enforcement personnel in Wadi al-Sayih.
- 51. At 2400 hours, an armed terrorist group opened fire on law enforcement personnel from the direction of the village of Husn.
- 52. At 0140 hours, an armed terrorist group opened intensive fire on law enforcement personnel near the 8th March roundabout, from the direction of the Abu Hurayrah mosque and the clinic.
- 53. At 0140 hours, an armed terrorist group opened intensive fire on law enforcement personnel near the Bab Tadmur roundabout, from the direction of the Shamas district.
- 54. At 0155 hours, an armed terrorist group opened fire on law enforcement personnel in Maydan Street.
- 55. At 0500 hours, an armed terrorist group opened fire on and launched a LAW rocket at law enforcement personnel near the citadel, from the direction of the Zaafaran mosque and Warshah district.
- 56. At 0555 hours, an armed terrorist group opened fire on law enforcement personnel on the international highway, from the direction of the Ramadi turn-off and Farhaniyah turn-off, hitting a bus carrying civilian passengers.
- 57. At 0625 hours, an armed terrorist group opened fire on law enforcement personnel near the 8th March roundabout.
- 58. At 0630 hours, an armed terrorist group opened fire on border guard personnel in the Nizariyah district, Qusayr.
- 59. At 0900 hours, an armed terrorist group opened fire on law enforcement personnel near the entrance to Tall Daww, killing Sergeant Ibrahim Khallouf and wounding Lieutenant Shahir Ibrahim.
- 60. At 0930 hours, an armed terrorist group opened fire on and launched mortars and gas grenades at law enforcement personnel in Wadi al-Sayih, wounding Lieutenant Colonel Manhal Shahadah.
- 61. At 0950 hours, an armed terrorist group opened fire on law enforcement personnel near the Farabi school.
- 62. At 0955 hours, an armed terrorist group opened fire on law enforcement personnel at the Gardenia tower in the Ghutah district.
- 63. At 1000 hours, an armed terrorist group shot and killed conscript Rami al-Hassan in Sitteen Street.
- 64. At 1000 hours, an armed terrorist group opened fire on law enforcement personnel in Jabb al-Jandali, from the direction of Warshah, wounding one.

- 65. At 1020 hours, an armed terrorist group opened fire on members of the Wa'r military college guard, wounding an officer cadet.
- 66. At 1030 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel near the Bab Tadmur roundabout, killing Corporal Salman Ibrahim, wounding five personnel, including Lieutenant Ala al-Ali, and destroying a vehicle carrying law enforcement forces.
- 67. At 1100 hours, an armed terrorist group attacked the railway station at Kafr 'Aya, wounding four personnel.
- 68. At 1100 hours, an armed terrorist group opened fire on and launched rocketpropelled grenades at law enforcement personnel in the Hamidiyah district, wounding two personnel.
- 69. At 1112 hours, an armed terrorist group opened fire on and launched mortars and gas grenades at law enforcement personnel in Wadi al-Sayih.
- 70. At 1215 hours, an armed terrorist group opened fire on law enforcement personnel near the Rastan bridge, wounding one.
- 71. At 1230 hours, an armed terrorist group opened sporadic fire on law enforcement personnel in Zayr Street, Bayyadah, Karm Shamsham.
- 72. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel near the Rizq Saloum school.
- 73. At 1410 hours, an armed terrorist group opened fire on and launched mortars and rocket-propelled grenades at law enforcement personnel near the Bab Tadmur roundabout.
- 74. At 1415 hours, an armed terrorist group opened fire on law enforcement personnel near the City Centre building, from the direction of the market.
- 75. At 1420 hours, an armed terrorist group opened fire on law enforcement personnel in Kafr 'Aya, wounding two.
- 76. At 1500 hours, an armed terrorist group attacked the law enforcement post near the citadel.
- 77. At 1500 hours, an armed terrorist group opened fire on law enforcement personnel near the village of Mushayrafah.
- 78. At 1600 hours, an armed terrorist group opened fire on a vehicle carrying civilians and law enforcement personnel as it was passing Talbisah, killing Muhammad Atro and wounding two law enforcement personnel and two military housing workers.
- 79. At 1600 hours, an armed terrorist group opened intensive fire on law enforcement personnel near the citadel from the direction of Warshah and the Zaafaran mosque.
- 80. At 1615 hours, an armed terrorist group opened fire on law enforcement personnel in the Qusur and Qarabis districts, killing conscript Tinus Kiliana.
- 81. At 1700 hours, an armed terrorist group opened fire on law enforcement personnel in Hulah, wounding Lieutenant Dirgham Ibrahim.

- 82. At 1730 hours, an armed terrorist group opened fire on and launched mortars and rocket-propelled grenades at law enforcement personnel near the Bab Tadmur roundabout.
- 83. At 1735 hours, an armed terrorist group opened intensive fire on law enforcement personnel in Jurah al-'Arayis.

Hama governorate

- 84. At 2000 hours on 27 May 2012, an armed terrorist group abducted conscripts Muhammad al-Baro and Muhammad al-Haddad, while on their way to work.
- 85. At 2000 hours on 27 May 2012, an armed terrorist group blocked the Aleppo road with burning tires, opposite the Buraq mosque.
- 86. At 2100 hours on 27 May 2012, an armed terrorist group shot and killed a child, Zayn Qantaqji, and wounded his father, Adnan Qantaqji.
- 87. At 2100 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in the Musha' al-Araba'in district, killing Private Usama Kakur and wounding five personnel.
- 88. At 2200 hours on 27 May 2012, an armed terrorist group shot citizen Khalid Zenoubia, near the Surayhin cemetery.
- 89. At 2230 hours on 27 May 2012, an armed terrorist group shot and killed citizen Ahmad Jawad in the Aleppo road district.
- 90. At 2300 hours on 27 May 2012, an armed terrorist group fired a rocket-propelled grenade at a house in the Abu'l Fida' suburb belonging to a major general, wounding a number of civilians.
- 91. At 2300 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement checkpoints in the Ta'awuniyah district, 'Ajazah roundabout, Hamidiyah district and station roundabout, wounding five personnel.
- 92. At 0100 hours, an armed terrorist group bombed the high-tension cable in the Sina'ah district, cutting off electricity to the area.
- 93. At 0100 hours, an armed terrorist group opened fire on the law enforcement checkpoint near the Hama steel factory, wounding one member of the law enforcement forces.
- 94. At 0400 hours, an armed terrorist group opened fire on the law enforcement checkpoint near the medical centre, wounding a female doctor and another woman.
- 95. At 0700 hours, an armed terrorist group deployed in the 'Aliliyat district of Hama and the district south of the stadium, as well as in the village of Taqsis. They terrorized the population and disrupted daily life in those areas.
- 96. At 0700 hours, an armed terrorist group shot and wounded a journalist, Ghayda Duhaymish in the Mukhayyam neighbourhood, stealing her gold jewellery and leaving her in the street.
- 97. At 0830 hours, an armed terrorist group deployed in the village of Karnaz and prevented people from going to work. They forced the owners of commercial premises to close.

- 98. At 0900 hours, an armed terrorist group shot and wounded Abdulqadir al-Fakhouri and his son, Yahya, as they were leaving their home in the Musha' al-Araba'in district.
- 99. At 0910 hours, an armed terrorist group abducted and killed citizen Amir Alwani.
- 100. At 1000 hours, an armed terrorist group abducted citizen Hatil Zayn near the Tagsis bridge.
- 101. At 1100 hours, an armed terrorist group planted an explosive device in the Zahiriyah district.
- 102. At 1130 hours, an armed terrorist group planted a number of explosive devices in the Musha' al-Araba'in district.
- 103. At 1215 hours, an armed terrorist group seized a Kia Rio, licence plate No. 316454, near the village of Amniyat from Dr. Muhammad Iyad Rahhal on his way back from the village of 'Asharinah.
- 104. At 1500 hours, an armed terrorist group abducted conscript Khali al-Diyab in the village of Rawdah.
- 105. At 1500 hours, an armed terrorist group opened fire on law enforcement personnel in Hama, killing conscript Muhammad Mahmoud al-Haj Muhammad Ramadan.
- 106. At 1500 hours, an armed terrorist group shot and killed citizen Muhsin al-Hamid near the Pullman station.
- 107. At 1600 hours, an armed terrorist group launched a rocket-propelled grenade at law enforcement personnel at the Sibahi roundabout, wounding three personnel, including Lieutenant Ahmad Mahmoud Hassan.
- 108. At 1800 hours, an armed terrorist group opened fire on citizens near the education directorate in Hama, killing Azam Anjidi and wounding one other.
- 109. At 1820 hours, an armed terrorist group detonated an explosive device as a law enforcement patrol was passing the Harsh roundabout in the Shari'ah district.
- 110. At 1920 hours, an armed terrorist group opened fire on the swimming pool checkpoint in the area south of the stadium, killing conscript Na'im al-Hassan.
- 111. At 1930 hours, an armed terrorist group launched several rocket-propelled grenades at a law enforcement checkpoint near the 'Ajzah roundabout, killing one and wounding seven personnel, including a lieutenant colonel.
- 112. At 1930 hours, an armed terrorist group planted more than 60 explosive devices in the Sayfi quarter, the city market and Jarajimah.

Aleppo governorate

- 113. At 2000 hours on 27 May 2012, an armed terrorist group attacked members of a police patrol in the city of Manbij, wounding one.
- 114. At 2100 hours on 27 May 2012, an armed terrorist group abducted two female teachers Abir Samrah and Yusra Adirah from the 'Aridah school in the Manbij district.

- 115. At 2100 hours on 27 May 2012, an armed terrorist group shot and wounded citizen Abdulkarim Asad in the Firdaws district.
- 116. At 2100 hours on 27 May 2012, an armed terrorist group shot and wounded citizen Wail Mahmoud Dib in the village of Tall Hawdan, district of Manbij.
- 117. At 2115 hours on 27 May 2012, an armed terrorist group shot and wounded citizen Sulayman Rashid in the district of Atarib.
- 118. At 2115 hours on 27 May 2012, an armed terrorist group shot and wounded citizen Yousef al-Umar on the Bab road.
- 119. At 2130 hours on 27 May 2012, an armed terrorist group shot and wounded citizens Abdullah Muhammad and Ali Muhammad beside the citadel.
- 120. At 2145 hours on 27 May 2012, an armed terrorist group shot and wounded citizen Taysir Dali Umar in I'zaz.
- 121. At 2200 hours on 27 May 2012, an armed terrorist group detonated an explosive device beside a passing police patrol in the district of Kallasah, wounding five personnel.
- 122. At 2200 hours on 27 May 2012, an armed terrorist group opened fire on a police patrol in Manbij.
- 123. At 2300 hours on 27 May 2012, an armed terrorist group held up a minibus, licence plate No. 357108, belonging to the pharmaceuticals company, at the Ma'mal turn-off in the Mansurah district.
- 124. At 2100 hours on 27 May 2012, an armed terrorist group detonated an explosive device in the Firdaws district, wounding a policeman.
- 125. At 0440, an armed terrorist group opened fire on and launched rocket-propelled grenades at a law enforcement checkpoint in the Zahra' district.
- 126. At 2300, an armed terrorist group fired two mortars at the Maydan engineering college.
- 127. At 0745 hours, an armed terrorist group detonated an explosive device beside a law enforcement patrol on the airport highway, opposite the scientific research centre, killing Major Haytham Haydar, Captain Maysir Salim, Lieutenant (Eng.) Salih Zaghrur and wounding 14 personnel.
- 128. At 0900 hours, an armed terrorist group opened fire on law enforcement personnel, killing conscript Khalid Shanan.
- 129. At 1100 hours, an armed terrorist group abducted the mayor of the village of 'Anjarah, Darah 'Izzah, Muhammad Rustum, as he was driving to the subdistrict of Darah 'Izzah.
- 130. An explosive device attached underneath a civilian Scania bus, licence plate No. 747596/Aleppo, driven by Firas Mustafa Adal, was detonated at the youth residence on the highway to Nirab military airport. The bus was carrying some 30 passengers, including officers, airport staff and civilians. Three officers were killed and seven others wounded; five personnel, one civilian and two workers were wounded.

Idlib governorate

- 131. At 0930 hours, an armed terrorist group held up the Jisr al-Shughur-Ariha road at the turn-off to the village of Kafr Najd.
- 132. At 1100 hours, an armed terrorist group abducted Chief Warrant Officer Ibrahim al-Muhammad as he was returning to his home in Ma'arat Misrin.
- 133. At 1500 hours, an armed terrorist group opened fire on a minibus on the Sarmin-Saraqib road, wounding a policeman and two others.
- 134. At 1600 hours, an armed terrorist group planted an 8-kilogram explosive device near the park behind the Ibn Sina hospital in Idlib.
- 135. At 1700 hours, an armed terrorist group held up the road to Atarib and undertook violent attacks against law enforcement personnel.
- 136. At 1245 hours, an armed terrorist group abducted three law enforcement personnel in Binnish: Corporal Hamid al-Hussein, Corporal Abdullah al-Uthman and Corporal Muhammad al-Jasim.
- 137. Two explosive devices were found on the Jisr al-Shughur-Idlib road, before the sugar factory; both devices were defused.
- 138. The body of a woman in her 20s was found at Habit quarry, west of Ma'arah Misrin.

Dayr al-Zawr governorate

- 139. At 2230 hours on 27 May 2012, an armed terrorist group abducted border guards Sergeant Hayyan Abdo and Corporal Tala Khudur in the 'Umar oil field, Mayadin district.
- 140. At 2300 hours on 27 May 2012, an armed terrorist group opened fire on the members of border guard post No. 178. The post was broken into, weapons stolen and five personnel abducted.
- 141. At 0245 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at a law enforcement post in the city of Dayr al-Zawr.
- 142. At 0300 hours, an armed terrorist group attacked the garage of the Hajnah municipality, stealing a tractor, trailer and water tanker.
- 143. At 0600 hours, an armed terrorist group held up the road in the subdistrict of Muhassan, attacked cars passing by and abducted Corporal Ahmad al-Saloum, a resident of Mayadin.
- 144. At 1100 hours, an armed terrorist group set up a roadblock in the village of Tishrin in Mayadin and checked passing vehicles; conscript Hussayn al-Mazaal was abducted.
- 145. At 1200 hours, an armed terrorist group attacked the education complex at Hajin, stealing a Nissan vehicle, licence plate No. 489739.
- 146. At 1240 hours, an armed terrorist group opened fire on a border guard patrol.
- 147. At 1300 hours, an armed terrorist group seized a Government vehicle belonging to the Mansouriyah Oil Services Company passing on the Dayr al-Zawr-Mayadin-Mari'iah road.

148. At 1300 hours, an armed terrorist group attacked the municipality building in Tayyib al-Fal, Busayrah, stealing a Government vehicle, licence plate No. 489695.

Raqqah governorate

- 149. At 2200 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in Tall Abyad, wounding one.
- 150. At 2300 hours on 27 May 2012, an armed terrorist group fired on Chief Warrant Officer Maan Maarouf, Chief Warrant Officer Ali Ibrahim and Chief Warrant Officer Imad Zureiq on the Aleppo-Raqqah road, near the village of Umm 'Adsah.
- 151. At 2330 hours on 27 May 2012, an armed terrorist group opened fire on law enforcement personnel in Bu'awad, Quriyah.

Ladhiqiyah governorate

- 152. At 0930 hours, an unidentified person attempted to set fire to two vehicles (a public service minibus and a Hyundai Verna taxi) belonging to Yasir Ghadir, while they were parked in front of his house in the village of 'Ayn al-Tinah.
- 153. At 1430, an unidentified terrorist detonated an explosive device of dynamite in a repair shop in the city of Jablah Jadid, wounding two persons: Mayadah Khazim and Fatin Hassan.
- 154. As a law enforcement and security patrol returning to the city of Ladhiqiyah from the subdistrict of Kinnsibba approached the Kafariyah bridge on the Ladhiqiyah-Aleppo road, an armed terrorist group opened fire, wounding Chief Warrant Officer Amir Mahfoud in the head.

Hasakah governorate
