Lettres identiques datées du 19 juin 2012, adressées au Secrétaire général et au Président du Conseil de sécurité par le Représentant permanent de la République arabe syrienne auprès de l'Organisation des Nations Unies

D'ordre de mon gouvernement et comme suite aux lettres que je vous ai adressées les 16 à 20 et 23 à 25 avril, 7, 11, 14 à 16, 18, 21, 24, 29 et 31 mai et 1^{er}, 4, 6, 7, 11 et 19 juin 2012, j'ai l'honneur de vous faire tenir ci-joint une liste détaillée des violations des dispositions du plan prévoyant la cessation de la violence, commises par des groupes armés en Syrie le 11 juin 2012 (voir annexe).

Je vous serais reconnaissant de bien vouloir faire distribuer le texte de la présente lettre et de son annexe comme document du Conseil de sécurité.

Monday, 11 June 2012

Rif Dimashq governorate

- 1. At 0300 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Hirista, wounding one member.
- 2. At 0330 hours, an armed terrorist group opened fire on the armaments department building.
- 3. At 0815 hours, an armed terrorist group in two Mercedes vehicles (unidentified license plate nos.), ambushed a military jeep passing through the city of Tall, killing Lieutenant Ali Sulayman and wounding Brigadier Abdulkarim Mustafa, Lieutenant Colonel Muhammad Shayha, Lieutenant Muhammad Satour and Sergeant Ali Fidah, who were taken to Tishrin military hospital. Several wounded terrorists were taken to the Raja' private hospital in Tall, which was surrounded by more than 100 armed men to prevent the security forces gaining access.
- 4. At 0900 hours, an armed terrorist group abducted Staff Sergeant Ramiz Khalaf in the Duwayla'ah district.
- 5. At 1000 hours, an armed terrorist group held up the road at the Hassan hospital in the Tall region.
- 6. At 1100 hours, an armed terrorist group detonated an explosive device beside a vehicle belonging to Colonel Ali Younis as it was passing through Barzah, wounding his son.
- 7. At 1100 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Duma, killing conscripts Ahmad Hamoud, Ali al-Furayj and Khidr al-Humaydan and wounding two personnel, including Lieutenant Colonel Jihad Khoury.
- 8. At 1800 hours, an armed terrorist group seized a vehicle, license plate no. 975798, belonging to Colonel Yasir Mansour and abducted the driver.
- 9. An armed terrorist group opened intensive fire on a public vehicle on the Damascus Aleppo highway, opposite the Syronics Company. The front half of the vehicle, a Hyundai Viera bearing license plate no. 812203/Damascus, appears to have been completely destroyed by fire; it contained the body of the driver. Investigation showed that the vehicle belonged to a Mazin Mahmoud al-Hamawi (born 1986). In addition to the driver, four other persons were in the said vehicle: conscript Salim al-Saloum ibn Mahmoud (born 1990), his brother 'Ala (born 1993), a relative of theirs, Khalifah al-Saloum ibn Shahadah (born 1995) and Muhammad al-Rahmu ibn Faysal (born 1990), shot several times in the back. They were all residents of the Qabun neighbourhood, Ba'lah district and had taken the vehicle from the Pullman arrival point. They did not know the driver's name.

- 10. In the city of Duma, five armed terrorists stole a Mazda pickup, license plate no. 888669/Damascus, belonging to Damascus International Airport, from the driver, Bashar Muhammad Abdulqadir al-Kaylani.
- 11. Two unidentified bodies were found in orchards in the city of Hirista.
- 12. In the city of Darayya, a Government-owned Mazda Zoom 3, bearing license plate no. 226584/Damascus, was stolen from in front of the house of the driver, Jamal al-Kawz.
- 13. In the city of Qatana, an armed terrorist group opened fire on army checkpoints, killing instantly a little girl, Nur al-Shaykh bint Dib and her brother, Anas.
- 14. An armed terrorist group stole a Nissan ambulance, license plate no. 531829/Rif Dimashq, with all its medical equipment, belonging to the Ma'lula clinic.
- 15. The body of a man in his 60s was found; he had been shot.
- 16. An armed terrorist group stole a Datsun double-cab pickup, license plate no. 930109/Rif Dimashq, belonging to the Darayya automatic bakery, and the sum of 225,000 Syrian pounds from the driver, Ayman Musa.
- 17. An armed terrorist group stole a Government Mazda, license plate no. 878639/Damascus, belonging to the Civil Aviation Authority.
- 18. An armed terrorist group killed two citizens: Haytham Abdulaziz Daoud, the mayor of Mu'addamiyah, and Mustafa Ali Shahadah, as well as another person from the Sha'ban family.
- 19. An armed terrorist group stole a Peugeot 504, license plate no. 779027/Rif Dimashq, belonging to the assistant director of education in Rif Dimashq governorate.
- 20. Muhammad Sa'id Khatab (born 1970), a discharged police lieutenant, was found shot dead.
- 21. An armed terrorist group stole a minibus, license plate no. 964168/Ladhiqiyah, belonging to the Ministry of Oil, on the Tall Dakwah road.
- 22. Three armed terrorists carrying military pistols stole a Government Toyota, license plate no. 88019/Damascus, belonging to the General Company for Roads and Bridges, from the driver, engineer Abdu Uthman.
- 23. A Mercedes 200, license plate no. 139626/Damascus, stopped at an Air Force security checkpoint in 'Aqraba and the driver, who was fastened by a steel chain, was told not to come any closer as the car was booby-trapped. Military engineers arrived and defused the device, which apparently weighed 700 kilograms. It appears that the driver, Ahmad Subhi al-Jasim, from Raqqah, was the husband of Captain Taghrid Hamdan, who had been abducted and killed two month ago.
- 24. A Government minibus carrying examination papers in the city of Yabrud, with a group of policemen inside and escorted by a patrol, was held up by armed men in several vehicles. When the driver of the minibus refused to stop, one of the vehicles blocked its way; the minibus crashed into this vehicle and was forced to stop. Meanwhile, the patrol continued on. There was an exchange of fire and the patrol

was pursued until the Nabk bridge. The armed men then forced the passengers of the minibus to get out. They stole two pistols belonging to two of the policemen as well as all mobile phones then left the location. Subsequently, the inhabitants of the district returned the examination papers without loss.

- 25. The district administrator of Duma was ambushed by and involved in a skirmish with armed men that left a policeman, Mazin Fa'our, wounded. He was taken to the police hospital.
- 26. In the city of Hirista, unidentified men shot a citizen, Ahmad Zaydan ibn Mustafa, wounding him in the chest and hip. He was taken to the police hospital.
- 27. In the town of Sayyidah Zaynab, a citizen, Ali Muhammad al-Hijar (born 1984), was shot and killed by two masked terrorists on a motorcycle.
- 28. In the Qastal district of city of Nabk, the body of an unidentified man was found; the body bore marks of torture.
- 29. In the city of Duma, an armed terrorist group stole a locked Mazda pickup, license plate no. 886007/Damascus, belonging to the electricity board.
- 30. In the city of Darayya, the body of an unidentified man, aged about 30, was found; he had been shot.
- 31. In the town of 'Irbin, Ibrahim Rujouf was abducted from in front of his house.

Damascus governorate

- 32. At 0230 hours, an armed terrorist group opened fire on the members of a guard post of the second company in 'Assal al-Ward, wounding one.
- 33. An explosive device was detonated beside a military vehicle, a Toyota bearing license plate no. 012101, opposite the Qasyun club in the residential neighbourhood of Barzah, as it was leaving the home of engineer Ali Muhammad, an employee of the Furat Petroleum Company. The driver, volunteer Corporal Durayd Ali Duyub, was killed and the vehicle completely burned out.
- 34. Chief Warrant Officer Ramzi Qaynur (born 1964) was admitted to the Ibn Nafis hospital for treatment after being shot in the head by an armed terrorist in Shaykh Khalid, in the Rukn al-Din neighbourhood, beside the Barniyah pharmacy.

Dar'a governorate

- 35. At 1800 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement checkpoints at the Nu'aymah bridge, the railway station and the Umm al-Mayadin bridge.
- 36. At 1930 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in 'Atman, killing Corporal Diya' al-Abdullah and wounding two.
- 37. At 2000 hours on 10 June 2012, an armed terrorist group opened random fire in downtown Dar'a, wounding one citizen.
- 38. At 2030 hours on 10 June 2012, an armed terrorist group shot and killed a citizen, Kamal al-Homsi, in Yadudah.

- 39. At 2100 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in Abta', killing a child, Khaldoun al-Rawashidah.
- 40. At 2200 hours on 10 June 2012, an armed terrorist group opened fire on the Sadd junction post of the law enforcement forces in downtown Dar'a.
- 41. At 0100 hours, an armed terrorist group opened fire on law enforcement personnel near the guidance unit, near the 'Uqbah ibn Nafi' mosque and in Sajnah.
- 42. At 0100 hours, an armed terrorist group opened fire on guard post no. 112 in Dar'a.
- 43. At 0430 hours, an armed terrorist group opened fire on the members of the Taybah police post.
- 44. At 0600 hours, an armed terrorist group opened sniper fire on law enforcement personnel in Busra al-Sham, wounding one.
- 45. At 0730 hours, an armed terrorist group abducted Chief Warrant Officer Muhammad al-'Uwaydat in 'Aqraba, as he was on his way to work.
- 46. At 0900 hours, an armed terrorist group held up the Damascus Dar'a highway at Khirbat Ghazalah, checking vehicles and terrorising passengers.
- 47. At 1000 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Ghariyah, wounding two personnel.
- 48. At 1200 hours, an armed terrorist group held up the road between the old customs and sports city and opened fire on passers-by, wounding two civilians.
- 49. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel attending to the wounded on the Qunayah Sanamayn road, killing Lieutenant Anas Hamadah.
- 50. At 1200 hours, an armed terrorist group ambushed a law enforcement patrol in the town of 'Atman, killing Lieutenant Colonel Ammar 'Ajib, abducting Major Lu'ayy Ahmad and wounding one patrol member.
- 51. At 1730 hours, an armed terrorist group opened fire on law enforcement personnel in 'Atman, wounding three.
- 52. At 1750 hours, an armed terrorist group abducted Sergeant Kamal al-Abdullah as he was driving on the Namir Shaykh Miskin road.
- 53. At 1800 hours, an armed terrorist group opened fire on law enforcement personnel in Tafas, wounding one.
- 54. Armed terrorists opened fire on security forces stationed in the Busra al-Sham citadel.
- 55. A fire broke out in a 150-dunum wheat field at Sariya, in the sub-district of Jasim. The inhabitants cooperated with the fire brigade in extinguishing it.

Homs governorate

56. At 1800 hours on 10 June 2012, an armed terrorist group attacked a military barracks in Ghantu, Rastan, killing seven personnel, wounding eight and abducting 44.

- 57. At 1900 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel in Rastan, killing conscripts Ahmad 'Isa and 'Ala al-Rahil, wounding 14, including Major Numayr Sulayman, and destroying two law enforcement vehicles.
- 58. At 2000 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Khalidiyah district, killing one, Siyah Yahya, and wounding 14.
- 59. At 2030 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades at personnel near the Muhandisin roundabout and Gardenia tower from behind the Tanur restaurant, as well as in Wadi al-Sayih and near the Khalid ibn al-Walid school; two personnel were wounded.
- 60. At 2030 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel near the blood bank in the Wa'r district and fired a mortar at the military hospital from the direction of the Wa'r gardens.
- 61. At 2100 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in the village of Diyabiyah, Qusayr, wounding six, including Lieutenant Colonel Samir Saloum.
- 62. At 2130 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel, wounding one.
- 63. At 2130 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel near the Qawas mosque and the Sabigh Company, wounding one.
- 64. At 2200 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel beside the citadel and the Farabi school.
- 65. At 2230 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Qarabis district, wounding two.
- 66. At 2230 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel in the Karm Shamsham district and Cairo Street.
- 67. At 2230 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in the village of Hisn.
- 68. At 2245 hours on 10 June 2012, an armed terrorist group shot and killed Lieutenant 'Abtan Yousef Murshid.
- 69. At 2300 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in the district of the health directorate, wounding one.
- 70. At 2315 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement personnel in Jurat al-Shayyah, killing conscript Rabi' Salamah and Corporal Asif Ibrahim and wounding 17, including Captain Basil al-Nash and Captain Fatir Ahmad.
- 71. At 2400 hours, an armed terrorist group opened fire on law enforcement personnel in Qusayr, wounding one.

- 72. At 2400 hours, an armed terrorist group opened fire on law enforcement personnel in Shayyahat, Qusayr, wounding one.
- 73. At 0130 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Rawdah, wounding one.
- 74. At 0600 hours, an armed terrorist group fired mortars at law enforcement personnel near Jurat al-'Arayis, from the direction of Bab al-Siba'.
- 75. At 0600 hours, an armed terrorist group opened fire on law enforcement personnel in the city of Talbisah.
- 76. At 0600 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel near the Qusayr municipality building, killing ten and wounding nine.
- 77. At 0600 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel in the city of Rastan, killing conscript Abdulwahhab Muhammad and wounding two others.
- 78. At 0900 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel near the Bab Tadmur roundabout.
- 79. At 0900 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel in Cairo Street and the Makatib roundabout.
- 80. At 0900 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel in the Khalidiyah district, killing Lieutenant Ammar Salamah and wounding five.
- 81. At 0930 hours, an armed terrorist group detonated an explosive device under a bus carrying soldiers between the villages of Hamra and Dumaynah, killing conscripts Khalid Hussayn al-Ahmad, Muhammad Nur al-Hussayn, Anas al-Hakwani and Mustafa Jum'a and wounding 13.
- 82. At 1000 hours, an armed terrorist group opened fire on law enforcement personnel near the dye works.
- 83. At 1030 hours, an armed terrorist group opened fire on law enforcement personnel near the citadel.
- 84. At 1130 hours, an armed terrorist group opened fire on law enforcement personnel in Wadi al-Sayih and near the health directorate, wounding one.
- 85. At 1145 hours, an armed terrorist group opened fire on law enforcement personnel near Gardenia tower.
- 86. At 1215 hours, an armed terrorist group opened fire on a law enforcement patrol stationed on the Damascus Homs road, killing Sergeant Usamah Ibrahim and wounding two personnel.
- 87. At 1230 hours, an armed terrorist group shot and killed Sergeant Hussam Turaybush and Staff Sergeant Ghayath Hassan in Ghantu, Rastan, and wounded one other.
- 88. At 1400 hours, an armed terrorist group opened fire on a military barracks in Homs, wounding one person.

- 89. At 1500 hours, an armed terrorist group opened fire on law enforcement personnel in Nizariyah, wounding two.
- 90. At 1530 hours, an armed terrorist group opened fire on the officers' club in Homs, wounding one person.
- 91. At 1600 hours, an armed terrorist group opened fire on law enforcement personnel in the village of Jabburin, Talbisah, wounding two.
- 92. At 1700 hours, an armed terrorist group opened fire on law enforcement personnel in the Mashtal area of Qusayr, wounding one.
- 93. A mortar fired by an armed terrorist group from the direction of Warshah fell near the Ruqayah school in the Zahra' district. The explosion wounded Mustafa Ramadan (born 1995) with shrapnel in the back. He was admitted to the Ahli hospital in Homs.
- 94. An armed terrorist group opened fire on law enforcement personnel in the city of Talbisah. The fate of the members of several of the checkpoints that were withdrawn is still unknown due to the loss of communications up to the time of preparing this list of violations.
- 95. An armed terrorist group opened machine gun and sniper fire on and launched rocket-propelled grenades at law enforcement personnel situated in the Qusayr municipality building, killing 12 and wounding eight. The remaining members were still surrounded at the time of preparing this list of violations.
- 96. Conscript Ahmad Bahjat al-'Isa (born 1991) and Corporal Abdulwahhab Hussayn al-Muhammad died after being taken to the military hospital from wounds sustained in the Talbisah sub-district. Fourteen personnel were taken to the said hospital with gunshot and shrapnel wounds sustained in the Qusayr district, the Talbisah sub-district, the Rastan region and Sittin Street.
- 97. An armed terrorist group opened machine gun fire on and launched rocket-propelled grenades and mortars at law enforcement personnel near the Qawas mosque and Sabigh Company, wounding one.
- 98. An armed terrorist group opened machine gun and sniper fire on law enforcement personnel beside the citadel and the Farabi school.
- 99. An armed terrorist group opened machine gun fire on and launched rocket-propelled grenades at law enforcement personnel near the Muhandisin roundabout and Gardenia tower from behind the Tanur restaurant, as well as in Wadi al-Sayih and beside the Khalid ibn al-Walid school; two personnel were wounded.
- 100. An armed terrorist group opened fire on law enforcement personnel near the blood bank and fired a mortar at the military hospital from the direction of the Wa'r gardens.

Hama governorate

- 101. At 2000 hours on 10 June 2012, an armed terrorist group held up an articulated truck, license plate no. 262665, at the village of Faydah on the Salamiyah Raqqah road, and stole its load of 55 tonnes of maize.
- 102. At 2300 hours on 10 June 2012, an armed terrorist group abducted Warrant Officer Musa al-Sutouf in the town of Kafr Nabudah.

- 103. At 2300 hours on 10 June 2012, an armed terrorist group shot and wounded a citizen, Nizar Haydar, at his farm in the village of Sathiyat in Salamiyah.
- 104. At 0330 hours, an armed terrorist group detonated two explosive devices in the western quarter of the village of Qumhanah, Suran, causing damage to an electricity box and a civilian vehicle.
- 105. At 0730 hours, an armed terrorist group opened fire on an overnight bus carrying law enforcement personnel as it was passing near the turn-off to the village of Mubarakiyat in Salamiyah, wounding Colonel Riyadh 'Imran, Lieutenant Colonel Fajr al-Salih, Major Asif Haurani, Captain Ayman 'Aboud and one other.
- 106. At 1000 hours, an armed terrorist group shot at a citizen, Rami al-Khatib, in the Mukhayyam district.
- 107. At 1100 hours, an armed terrorist group beat up a citizen, Yousef al-Faraj, on the Murak Ma'an highway and stole the sum of 30,000 Syrian pounds from him.
- 108. At 1200 hours, an armed terrorist group stole a Government pickup, license plate no. 941780, belonging to the General Company for Roads and Bridges, between the health directorate roundabout and the Jubb roundabout.
- 109. At 1230 hours, an armed terrorist group stole a Government vehicle, license plate no. 939469, belonging to the Hama municipality, in the Hadir district.
- 110. At 1330 hours, an armed terrorist group broke into the 'Asi pump station in the village of Jajiyah and stole the guard's weapon.
- 111. At 1330 hours, an armed terrorist group stole a tracked vehicle, license plate no. 2733, belonging to the technical services directorate, on the Salamiyah Hama road.
- 112. At 1330 hours, an armed terrorist group assaulted a policeman, Mustafa Zaydan, and stole his weapon.
- 113. At 1400 hours, an armed terrorist group stole a Government vehicle, license plate no. 941361, belonging to the General Company for Roads and Bridges, between the prison roundabout and the Muzarib district.
- 114. At 1930 hours, an armed terrorist group abducted a citizen, Muhammad Abu Shalash, from in front of his house in Murak and terrorized his family by firing into the air.

Aleppo governorate

- 115. At 0730 hours, an armed terrorist group abducted Lieutenant Colonel Haytham Shudud from his home in Bab, Aleppo.
- 116. At 1400 hours, an armed terrorist group stole a Mercedes, license plate no. 60360, used by Brigadier Hafiz Kurum, near the Ramusah roundabout; four personnel were in the vehicle at the time.
- 117. At 1700 hours, an armed terrorist group detonated an explosive device beside a law enforcement patrol near the Ways factory; the vehicle overturned, wounding four personnel.
- 118. At 1800 hours, an armed terrorist group opened fire on and launched rocket-propelled grenades at law enforcement personnel in Huraytan, setting two vehicles

- on fire and wounding Brigadier Jamal Jami' and one other. A Hyundai, license plate no. 469917, carrying several of the wounded to hospital went missing, together with five personnel.
- 119. An armed terrorist group placed an explosive device, estimated to weigh 30 kilograms, at the end of the Sakhur bridge on the road to Hanano and when a squad of military engineers arrived to defuse it, detonated the device remotely; no material or human damage was caused. Subsequently, a second device was detonated about 100 metres from the first on the same road but no material or human damage was caused.
- 120. An armed terrorist group in two vehicles, estimated to number 15 persons, wearing standard military dress and armed with Kalashnikov rifles, attacked personnel guarding agricultural land in the village of Shaykh Ahmad. The group fled when confronted, leaving one guard, Hussam Mushawlah ibn Ahmad (born 1977) dead and another, 'Adnan Khidr al-'Awad (born 1975) with two gunshot wounds.
- 121. Conscript Sergeant Khalaf al-Ahmad was taken to the Kindi hospital, fatally wounded by gunshot in the vicinity of the town of 'Anadan.

Idlib governorate

- 122. At 0400 hours, an armed terrorist group opened fire on law enforcement personnel in the village of Lujj, killing a conscript, Mahmous al-'Alu.
- 123. At 0700 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the Kafr Najd turn-off, wounding one member.
- 124. At 0830 hours, an armed terrorist group detonated an explosive device beside a law enforcement patrol passing the Sham'at roundabout in the Thawrah district, killing Captain Ahmad Talib and five policemen: Sa'id al-'Ali, Abdulgadir Muhammad, Ahmad Muhammad, Ahmad al-Habib and Basim al-'Assaf, and wounding two citizens. In addition, there was material damage to the patrol vehicle and adjacent buildings.
- 125. At 1000 hours, an armed terrorist group opened sniper fire on law enforcement personnel in Has, wounding one.
- 126. At 1000 hours, an armed terrorist group attempted to hold up the Hama Ma'arrah international highway at Hamidiyah.
- 127. At 1100 hours, an armed terrorist group opened fire on a rations vehicle belonging to the law enforcement forces as it was passing on the Jisr al-Shughur Darkush road, killing Corporal Khidr Hassan and conscript Mahmoud Nuh and wounding six personnel, including Lieutenant Zakaria al-Nasir.
- 128. At 1245 hours, an armed terrorist group detonated an explosive device beside a law enforcement patrol at the Nahlaya turn-off on the Mastumah Ariha road, killing two personnel.
- 129. At 1345 hours, an armed terrorist group abducted Colonel Yasir Muhammad al-Shaykh Ahmad as he was driving on the Abu al-Duhur Tall al-Daman road.
- 130. At 1430 hours, an armed terrorist group attempted to hold up the Ladhiqiyah Jisr al-Shughur road at 'Ayn Hawr to terrorize passers-by.

- 131. At 1600 hours, an armed terrorist group opened fire on the vehicle of Hassan Fandi near the entrance to Ma'arrat al-Nu'man.
- 132. The body of Ward al-Misri ibn Mustafa (born 1994) was found behind the Furqan mosque, shot once in the head and once in the chest.
- 133. Violent clashes took place between armed terrorist groups deployed in the city of Ma'arrat al-Nu'man and army and law enforcement checkpoints. More than 500 armed men attacked the checkpoint at the district administrative building; the clash lasted more than five hours.
- 134. An armed terrorist group abducted Captain Ahmad al-Hassan and Lieutenant Ali al-Hassan on the Turmanin Dana highway, as they were on their way to their units. They were led off to an unknown destination.

Dayr al-Zawr governorate

- 135. At 2000 hours on 10 June 2012, an armed terrorist group opened fire on law enforcement checkpoints near the Dallah roundabout, wounding one person.
- 136. At 2200 hours on 10 June 2012, an armed terrorist group launched a rocket-propelled grenade and a thermal rocket at a law enforcement checkpoint in Quriyah.
- 137. At 0100 hours, an armed terrorist group broke into the Sal'u Agricultural Research Centre, looting the contents and stealing 137 head of sheep, an agricultural tractor and 500 litres of diesel oil.
- 138. At 0230 hours, an armed terrorist group attacked a law enforcement checkpoint near Jisr al-'Asharah, killing one, wounding three, including Lieutenant Ahmad Ali, and abducting 32 personnel; two vehicles belonging to the law enforcement forces were destroyed.
- 139. At 0400 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the Dallah roundabout, wounding one person.
- 140. At 0700 hours, an armed terrorist group abducted engineer Rami on his way to work at the Jazrah field.
- 141. At 0730 hours, an armed terrorist group held up Salah Salibah, director of energy at the Public Establishment for Electricity Generation and Transmission on his way to work; he was beaten up and his vehicle stolen.
- 142. At 0745 hours, an armed terrorist group shot at and abducted the son of Colonel Mashour Hassan as he was on his way to sit an examination.
- 143. At 0800 hours, an armed terrorist group opened fire on law enforcement personnel in Dayr al-Zawr, wounding one.
- 144. At 0900 hours, a policemen, Ahmad Sidou, was killed by an armed terrorist group; he had been kidnapped the day before in Bu Kamal.
- 145. At 1230 hours, an armed terrorist group opened fire on law enforcement personnel in Busayrah.
- 146. At 1500 hours, an armed terrorist group opened fire on a law enforcement patrol in Mayadin, damaging the vehicle.

- 147. At 1600 hours, an armed terrorist group opened fire on the Kanamat checkpoint of the law enforcement forces, wounding one.
- 148. At 1500 hours, an armed terrorist group opened fire on a law enforcement patrol in Mayadin, damaging the vehicle.
- 149. At 2200 hours, an armed terrorist group opened fire on a guard post of the first company in Jaz'ah.
- 150. An armed terrorist group fired volleys from a variety of weapons at the political security detachment in the Kisrah sub-district.
- 151. An armed terrorist group fired volleys from a variety of weapons at police headquarters, the branch of political security and at security and law enforcement checkpoints and patrols stationed in the city of Dayr al-Zawr. Fire was returned and two personnel were wounded.
- 152. An armed terrorist group fired volleys from a variety of weapons at a law enforcement checkpoint at Jisr al-'Asharah. Fire was returned and one of the law enforcement personnel was killed; an officer and one other were wounded.
- 153. The body of an unidentified man in his twenties was found on the Shuhayl Busayrah road; his hands were tied and he had been shot in the head.
- 154. An armed terrorist group, estimated to number approximately 15 men, broke into the Shuhayl municipality building, smashing the doors. They stole a Caterpillar 950 and a Government digging machine, license plate no. 489605/Dayr al-Zawr.
- 155. An armed terrorist group set up a roadblock at the village of Bu Layl on the Dayr al-Zawr Mayadin highway to terrorize passing vehicles.

Ladhiqiyah governorate

- 156. At 2000 hours on 10 June 2012, an armed terrorist group opened fire on and launched rocket-propelled grenades and mortars at law enforcement personnel in Haffah, killing Chief Warrant Officer Iyad Armit and conscript Ziyad al-'Alu and wounding 36, including Captain Basil 'Aqil.
- 157. Unidentified men placed several burning tyres on Iskan Street in the Salibah district and fled before law enforcement squads arrived to extinguish the fires and re-open the road. As the patrol was returning, an unidentified man threw a stick of dynamite near the Salibah police station squad and two policemen, Yousef Dhahru and Ammar al-Khalaf, suffered concussion from the force of the blast; they were taken to the national hospital in Ladhiqiyah. The squad vehicle sustained slight damage.
- 158. A large number of armed terrorists attacked a security and law enforcement checkpoint in the village of Salma, in the sub-district of Salinfah, hitting it with several rocket-propelled grenades.

Hasakah governorate

159. At 2200 hours, an armed terrorist group attacked guard post no. 112, killing Staff Sergeant Hussam Mahmoud and abducting conscript Taha Ramadan, conscript Amir Barghashi and civilian guard Ali al-Rajb; three weapons were stolen.

Syrian-Lebanese border

160. At 0200 hours, an armed terrorist group opened fire from inside Lebanese territory at members of border guard post no. 52, in the Fadiliyah district.

Syrian-Iraqi border

161. At 2200 hours on 10 June 2012, an armed terrorist group attempted to infiltrate Syrian territory from Iraqi territory, at Jazʻah.

Syrian-Turkish border

162. At 0500 hours, an armed terrorist group attempted to infiltrate Syrian territory from Turkish territory through the woods by the town of Khirbat al-Jawz.
