# Rif Dimashq governorate

- 1. At 2200 hours on 25 June 2012, an armed terrorist group stole an electrical cable 300 metres in length from the Dayr al-Hajar agricultural project, which is being implemented in the context of the fourth cooperation framework in Dayr al-'Asafir.
- 2. At 0500 hours, an armed terrorist group opened fire on law enforcement personnel in Hamah, killing Sergeant Samir al-Tawil and conscripts Mahmud al-Najm, Ghassan Falu, Ahmad al-'Aziz and Khalil al-Faraj, and wounding 10 others.
- 3. At 0725 hours, an armed terrorist group detonated an explosive device in the car of Colonel Ahmad Hasan at the Four Seasons turnoff on the Sahnaya-Judaydat Artuz road, killing the colonel and injuring his driver.
- 4. At 0800 hours, an armed terrorist group in the Ra's al-'Ayn district opened fire on a private car in which Warrant Officer Hisham al-Susah was riding, killing him. The terrorists then dismembered the body and put the pieces into bags, which they left near the Ra's al-'Ayn turnoff. They also stole the car and the officer's weapon.
- 5. At 0810 hours, an armed terrorist group intercepted Fox Fagan's car, licence plate No. 178174, beat and abducted the driver, and stole the car.
- 6. At 1200 hours, an armed terrorist group opened fire on a military barracks in Damir from the direction of Suq al-Sabt.
- 7. At 1215 hours, an armed terrorist group opened fire on law enforcement personnel in Rif Dimashq, killing Lieutenant Usamah al-Masri.
- 8. At 1300 hours, an armed terrorist group opened fire on law enforcement personnel in Darayya, wounding one officer.
- 9. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel in Sigba, wounding one officer.
- 10. The body of a civilian of Palestinian nationality, Ahmad Husayn al-Ahmad, born in 1954, was found in Duma city. He had been shot by persons unknown.
- 11. In Darayya city, a Kia Cerato, licence plate No. 724492 (Damascus), was commandeered from its driver, Ahmad Khidr.
- 12. An armed terrorist group invaded Darayya school No. 8 and the Hikmah school for boys in Darayya, ransacking and smashing whatever they found there and stealing four computers, a receiver, an amplifier, a scanner, and a rifle.
- 13. An armed terrorist group attacked law enforcement personnel in Darayya, but no one was injured.

- 14. In Sayyidah Zaynab town, an armed terrorist group invaded and ransacked the Guidance Unit in Hujayrah.
- 15. In Jaramana town, the body of an individual in his 20s was found near the turnoff for the Sayyid al-Ra'is roundabout. The victim had been shot in the head.
- 16. In Duma city, an armed terrorist group commandeered a closed truck belonging to the Desert Development Department, licence plate No. 935295 (Homs), from its driver, Muhammad Ala'addin.
- 17. An unidentified body was found in Ayn al-Fijah.
- 18. An armed terrorist group estimated at more than 100 individuals surrounded the Darayya district building, blocked all roads leading to it with pickups having machine guns and rocket-propelled grenade launchers mounted on them, and summoned the personnel there to surrender and hand over their weapons. This situation continued until one o'clock in the morning. The terrorists then withdrew after attacking the building and throwing a hand grenade into the mausoleum of Sayyidah Sakinah. The grenade failed to explode and was defused by army engineers.
- 19. The body of a police officer, Umar al-Jabr, was found in front of his home in Darayya, behind the national hospital. He had been shot a number of times in the head and chest.
- 20. In Yabrud city, the body of an unidentified man was found near the Jarrah roundabout. The victim had been shot. The body was taken to the Qalamun hospital.
- 21. In Irbin town, an armed terrorist group stole a Peugeot 504, licence plate No. 003851 (Damascus), belonging to the Ra'i al-Salih orphans' home.

# Damascus governorate

- 22. At 0130 hours, a patrol of the Yarmuk police detachment found a black nylon bag containing an unknown object in a concealed location opposite the detachment post, over towards the Bahrah roundabout. The object proved to be a 5-kg explosive device. It was taken to a location on 30th Street in the Qadam Gardens and detonated by a team of army engineers. There were no injuries or damage.
- 23. At 0500 hours, an armed terrorist group hiding in the stands at the Fayha' stadium, in the Damr quarter, opened fire on Dr. Faysal al-Miqdad's bodyguards. The guards returned fire and the terrorists fled.
- 24. At 0730 hours, a body was found on the ground near Tal'at Layali al-Sham in the Rukn al-Din neighbourhood. It proved to be that of a civilian, Khalid Iwad ibn Abdullah, born in 1962, of Palestinian nationality, who had been employed at the military housing facility.
- 25. At 0845 hours, a police officer, Muhammad Ali Khadur, was shot by an armed terrorist group as he was on his way to his job as a guard at the Barzah branch of the Commercial Bank of Syria, which is located in the Masbaq al-San' district, near the Khansa' mosque.
- 26. The body of a girl in her 20s was found in Maliki Street in the Tadamun quarter, opposite the Ni'mah bakery. She had been shot in the head, there were a

number of abrasions on the head and body, and the feet were tied. She was identified as Badris bint Muhammad Dib al-Habash.

- 27. At 1000 hours, an armed terrorist group abducted Major General Faraj al-Maqt on the Adawi highway.
- 28. At 1000 hours, the body of a woman was found at Jawbar near the Harmalah underpass. The victim was identified as Kinanat Nasir bint Najib, born in 1947. Investigation revealed that two unknown individuals had shot her in front of the door of her home and had then quickly disappeared carrying a black handbag.
- 29. At 1000 hours, a civilian, Ghassan ibn Muti' Humaydan, born in 1977, was brought to the Damascus hospital with an injury to his left foot. He was a civilian employee at the defence factories in the vicinity of the Ayshah River. Another civilian, a woman named Rina bint Yusuf Dayub, born in 1984, was also taken to that hospital with an injury to her left ear. Both victims had been injured by an explosive device that had been placed under the driver's seat of a Lada driven by Ghassan and exploded just as Rina was entering the car. The incident occurred in the Dahadil neighbourhood.
- 30. At 1330 hours, an armed terrorist group opened random fire in the Pullman garage, damaging a number of vehicles.
- 31. At 1700 hours, a young girl named Nakid bint Mazin, approximately 12 years of age, was rushed to the Mu'asah hospital, where she died as a result of a bullet wound between the eyes and another in her right ear. She had been shot by armed terrorists in Liwan in the Kafr Susah quarter.
- 32. At 1830 hours, a civilian, a woman named Manal al-Faqir bint Muhammad Subhi, approximately 35 years of age, was rushed to the Andalus hospital with a bullet wound in the pelvis. She had been shot by armed terrorists among the gardens in Liwan in the Kafr Susah quarter.

# Dar'a governorate

- 33. At 2000 hours on 25 June 2012, an armed terrorist group abducted a civilian, Yasin al-'Atili, in Jizah.
- 34. At 2000 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel at the central post office, the clinic, the bakery and the far end of the Abbasiyin quarter in Dar'a town.
- 35. At 2000 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement checkpoints at the railway station, Humaydat al-Tahir and the Nu'aymah bridge in Dar'a.
- 36. At 2100 hours on 25 June 2012, an armed terrorist group shot and wounded a civilian, Ghassan Zurzur, in Dar'a.
- 37. At 2100 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel at the intersection of the dam road and the entrance to the camp in Dar'a.
- 38. At 2130 hours on 25 June 2012, an armed terrorist group stole a Mercedes water tanker, licence plate No. 879339, belonging to the Agriculture Directorate in Dar'a.

- 39. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on the border guards in the Tall al-Bargah district, west of Kharab al-Shahm.
- 40. At 2200 hours on 25 June 2012, an armed terrorist group intercepted a civilian, Ali Faris, who was driving a car carrier in Dar'a, and stole eight cars.
- 41. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on a law enforcement checkpoint in Tafas, near the Ba'l mosque.
- 42. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement checkpoints near the Guidance Unit and near the Uqbah ibn Nafi' mosque in Dar'a town.
- 43. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on a law enforcement checkpoint near the old Customs building in Dar'a town.
- 44. At 2200 hours on 25 June 2012, an armed terrorist group first abducted and then shot and killed a civilian, Ali al-Sayyid, in Khirbat Ghazalah.
- 45. At 2300 hours on 25 June 2012, an armed terrorist group shot and killed a civilian, Muhammad al-Kafri, in Jamrin.
- 46. At 0000 hours, an armed terrorist group opened fire on law enforcement personnel and a military barracks in Harah town.
- 47. At 0100 hour, an armed terrorist group stole a Baker crawler tractor belonging to the municipality in Dar'a.
- 48. At 0500 hours, an armed terrorist group shot a civilian, Yazin al-Himsi, in front of his home in Kahil.
- 49. At 0830 hours, unknown armed terrorists opened fire on security and law enforcement personnel in the centre of the Jasim locality and at their station. The men returned fire. There were no casualties.
- 50. At 0845 hours, two armed terrorists on a motorcycle shot a civilian, Khalil Ibrahim al-Hariri, 50, in the head, fatally wounding him, while he was buying a loaf of bread.
- 51. At 0900 hours, an armed terrorist group detonated an explosive device in a food delivery vehicle belonging to the law enforcement forces near the firing range in Basr al-Harir. The driver was injured and the vehicle damaged.
- 52. At 1045 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the Ba'th school and the athletic club in Dar'a town. The officers returned fire. There were no casualties or damage.
- 53. At 1200 hours, an armed terrorist group abducted a police officer, Midyan al-Husayn, in Ma'rabah as he was on his way to work.
- 54. At 1230 hours, an armed terrorist group invaded the home of a civilian, Bahij Faluh, and also the home of his son, and stole a quantity of money and gold worth an estimated 725,000 Syrian pounds.
- 55. At 1330 hours, an armed terrorist group detonated an explosive device among law enforcement personnel in Atman town near the party offices, killing conscript Saddam al-'Ubayd and injuring two other officers.

- 56. At 1330 hours, an armed terrorist group opened fire on law enforcement personnel near the Tall Arar turnoff south of Majbal, wounding one officer.
- 57. At 1345 hours, an armed terrorist group opened fire on the men at post No. 45 from among some olive trees in the Nasirah district.
- 58. At 1400 hours, an armed terrorist group abducted a civilian, Yasin al-Ahmad, in Jizah.
- 59. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel near the Umari mosque in Dar'a town, killing conscript Riyad Azzawi.
- 60. At 1445 hours, an armed terrorist group detonated an explosive device while a food delivery vehicle belonging to the law enforcement forces was passing. Two officers were injured.
- 61. At 1500 hours, an armed terrorist group opened fire on a military barracks in Kafr Shams.
- 62. At 1500 hours, an armed terrorist group opened fire on a law enforcement patrol vehicle at the railway station in Dar'a, wounding one officer.
- 63. At 1700 hours, an armed terrorist group opened fire on law enforcement personnel in Kafr Shams town, killing Chief Warrant Officer Sa'id Sallum and conscript Yasir Talalidi and wounding nine other officers.

## Homs governorate

- 64. At 2000 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel beside the Khalid ibn al-Walid school and the Basman hotel.
- 65. At 2000 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in Rastan, wounding one officer.
- 66. At 2100 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel by the university campus.
- 67. At 2200 hours on 25 June 2012, an armed terrorist group opened fire and launched rocket-propelled grenades at law enforcement personnel in Sultaniyah village and near the oil pipeline.
- 68. At 2200 hours on 25 June 2012, an armed terrorist group opened heavy fire and launched barrages of rocket-propelled grenades and mortar rounds at law enforcement personnel in Hisn beside the Awjah roundabout, the Zarah bridge, and the villages of Bisas, Qumayrah, Barda'iyat and Jabal al-Sayih.
- 69. At 2300 hours on 25 June 2012, an armed terrorist group opened fire on a military barracks in Homs, wounding one guard.
- 70. At 2315 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel beside the Education Directorate from the direction of the Dablan quarter and Ghutah.
- 71. At 2330 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in Bab al-Siba', near the citadel.

- 72. At 0500 hours, an armed terrorist group opened fire and launched rocket-propelled grenades at law enforcement personnel in Sultaniyah village and near the oil pipeline, wounding one officer.
- 73. At 0600 hours, an armed terrorist group opened fire on law enforcement personnel in the Qusur quarter, wounding three officers.
- 74. At 0600 hours, an armed terrorist group opened fire on law enforcement personnel in Qahirah Street and near the Makatib roundabout.
- 75. At 0600 hours, an armed terrorist group opened fire on law enforcement personnel in Jawrat al-Shiyah, killing three officers, one of whom is known to have been Corporal Bashshar Qasim, and wounding eight others, including a lieutenant colonel.
- 76. At 0700 hours, an armed terrorist group opened fire on law enforcement personnel in Qusayr, killing conscript Ammar Hasidah.
- 77. At 0800 hours, an armed terrorist group opened fire on law enforcement personnel in Rastan.
- 78. At 0900 hours, an armed terrorist group opened sporadic fire on law enforcement personnel in Mazari' Bab Amr from the direction of Sultaniyah, wounding one officer.
- 79. At 1000 hours, an armed terrorist group opened sporadic fire on law enforcement personnel in Bab al-Siba' from the direction of the Safsafah quarter.
- 80. At 1100 hours, an armed terrorist group opened sporadic fire on law enforcement personnel in Jubb al-Jandali.
- 81. At 1300 hours, an armed terrorist group opened fire on a military barracks in Homs, killing Sergeant Isa Qatish.
- 82. At 1500 hours, an armed terrorist group opened fire on law enforcement personnel at the entrance to Kafr Aya, abducting six officers with their weapons, including one with the rank of captain. In addition, eight officers were wounded in the attack, one of them a lieutenant colonel.
- 83. At 1800 hours, an armed terrorist group opened fire on law enforcement personnel in Bab al-Siba' from the direction of the hay market.
- 84. At 1900 hours, an armed terrorist group opened fire and launched rocket-propelled grenades at law enforcement personnel in Qarabis and the Qusur quarter.

# Hama governorate

- 85. At 2100 hours on 25 June 2012, an armed terrorist group opened fire on a military barracks in Hama, wounding one guard.
- 86. At 2200 hours on 25 June 2012, an armed terrorist group ambushed and opened fire on two law enforcement patrol vehicles as they were proceeding along the agricultural road between the villages of Aqrab and Ba'rayn.
- 87. At 0200 hours, an armed terrorist group attacked a law enforcement checkpoint on the Ma'ardis-Tayyibat al-Imam road, killing Corporal Ibrahim al-Nasir and wounding four other officers.

- 88. At 0400 hours, an armed terrorist group shot and killed a civilian, Khalid al-Mujbir, in Halfaya.
- 89. At 0800 hours, an armed terrorist group intercepted a truck carrying fabrics and food products, licence plate No. 845841, on the Salamiyah-Raqqah road near the Natahij turnoff. The truck was driven by a civilian, Daham Shahadah.
- 90. At 0800 hours, an armed terrorist group shot a civilian, Muhammad Ibrahim, as he was delivering bread in Raba.
- 91. At 1100 hours, an armed terrorist group abducted a police officer, Ahmad al-Mash'an, on the Hama-Aleppo road near Mawrik town.
- 92. At 1200 hours, an armed terrorist group abducted a civilian, Ammar al-Muhammad, from his home in Kawkab village.
- 93. At 1200 hours, an armed terrorist group planted an explosive device near the Third Industrial Institute.
- 94. At 1300 hours, an armed terrorist group intercepted a vehicle, licence plate No. 271190, as the driver was bringing it in to the Hama petrol station to fill the fuel tank. The terrorists commandeered the car and abducted conscript Muhammad Hamid and Sergeant Assaf al-Muhammad.
- 95. At 1400 hours, an armed terrorist group commandeered a car, licence plate No. 831965, from its driver, a civilian named Muhammad al-Hasan, as he was driving near the Ayn al-Bad turnoff.
- 96. At 1400 hours, an armed terrorist group detonated an explosive device in a food delivery vehicle belonging to the law enforcement forces as it was proceeding along the Maharda-Ghab road, at the Qaramitah turnoff.
- 97. At 1500 hours, an armed terrorist group commandeered a Government vehicle, licence plate No. 475187, belonging to the Technical Services Directorate as it was proceeding through Harbanafsah east of Aqrab town. The driver was Khalid al-Fajr, Engineer.
- 98. At 1600 hours, an armed terrorist group detonated an explosive device in a law enforcement patrol vehicle as it was proceeding through Qal'at al-Madiq, and a second device in an ambulance.

#### Aleppo governorate

- 99. At 2100 hours on 25 June 2012, an armed terrorist group abducted a civilian, Ayman Kan'an, from his shop in the Ashrafiyah quarter. His family were contacted by some persons claiming to be the Free Army, who demanded information about law enforcement personnel, and subsequently killed him.
- 100. At 2140 hours on 25 June 2012, an armed terrorist group opened fire on a number of civilians who happened to be in the street in the Sukkari neighbourhood of the Zarazir district. Three of them were wounded.
- 101. At 2230 hours on 25 June 2012, an armed terrorist group detonated three explosive devices in police patrol vehicles in Salah al-Din, wounding seven officers. One of the vehicles was set on fire and the other two were damaged. The terrorists also stole a rifle.

- 102. At 2230 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in Aleppo, killing conscript Yaman Abu Hawiyah and wounding another officer.
- 103. At 0200 hours, an armed terrorist group opened fire on law enforcement personnel in Aleppo, killing conscript Abdulmun'im Muhammad.
- 104. At 0700 hours, an armed terrorist group ambushed a law enforcement patrol vehicle as it was proceeding through Huraytan, wounding six officers, two of them seriously.
- 105. At 0700 hours, an armed terrorist group opened fire on law enforcement personnel in I'zaz city.
- 106. At 0900 hours, an armed terrorist group planted an explosive device under a coffee stall in Sukkari.
- 107. At 1000 hours, an armed terrorist group opened fire on law enforcement personnel in Aleppo, wounding a captain.
- 108. At 1100 hours, an armed terrorist group invaded the storage depot of the Iceman-Milkman Company in Khan al-'Asal and stole 20 refrigerated vans loaded with ice cream.
- 109. At 1215 hours, an armed terrorist group detonated a noise bomb in the Masakin Hananu quarter beside a trash container, damaging a vehicle belonging to a civilian, Muhammad Mazik, which happened to be near the site of the explosion.
- 110. At 1630 hours, an armed terrorist group threw an explosive device at the Public Corporation for Roads and Bridges office in the Sayf al-Dawlah area.
- 111. At 1700 hours, an armed terrorist group opened fire on the Minkh airport from the north, northeast and east.

# Idlib governorate

- 112. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in Jabal al-Zawiyah in Barah village, wounding one officer.
- 113. At 0500 hours, an armed terrorist group opened fire on law enforcement personnel on the road from Ma'arrah to Saraqib (Qahirah'Khan al-Sabal), killing 3 officers, wounding 25 and destroying a number of vehicles.
- 114. At 0600 hours, an armed terrorist group blew up a booby-trapped car in the midst of law enforcement personnel in Jabal al-Zawiyah in Barah village, killing conscripts Basil Uthman, Muhammad al-'Arif and Abdurrahman al-'Abbud and injuring 19 others, including 2 lieutenants.
- 115. At 0800 hours, an armed terrorist group opened fire on law enforcement personnel at Khan al-Sabal on the Ma'arrah-Saraqib road, killing conscript Abdulkarim al-'Alawi.
- 116. At 0900 hours, an armed terrorist group blew up a booby-trapped car near the road junction in Khan Shaykun city, killing conscript Bilal Mar'i and wounding eight other officers.

- 117. At 1000 hours, an armed terrorist group detonated an explosive device in a law enforcement patrol vehicle at Tarnabah on the Idlib-Saraqib road, wounding one officer.
- 118. At 1130 hours, an armed terrorist group opened fire on a law enforcement checkpoint by the prison near Ma'arrat al-Nu'man, wounding one officer.
- 119. At 1130 hours, an armed terrorist group opened fire on law enforcement personnel at Abu al-Duhur in the Saraqib district, wounding two officers.
- 120. At 1313 hours, an armed terrorist group opened fire on law enforcement personnel in Saraqib, wounding two officers.
- 121. At 1315 hours, an armed terrorist group opened fire on law enforcement personnel at Ma'arr Dibsah on the Ma'arrah-Saraqib road, killing Lieutenant Ali Hasan and wounding two other officers, one of them a colonel.
- 122. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel at Khan al-Sabal on the Saraqib-Ma'arrah road, wounding three officers and destroying two cars belonging to the law enforcement forces.
- 123. At 1600 hours, an armed terrorist group opened fire on a law enforcement patrol vehicle in Saraqib, killing one officer and wounding another.
- 124. At 1630 hours, an armed terrorist group planted an explosive device under the bridge in Awram al-Jawz.
- 125. At 1800 hours, an armed terrorist group detonated an explosive device in a law enforcement patrol vehicle as it was proceeding through the Saraqib district, injuring one officer.
- 126. At 1900 hours, an armed terrorist group opened fire on law enforcement personnel at the highway police post in Khan Shaykun, wounding one officer.
- 127. At 1900 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the footbridge in Ma'arrah town.

#### Dayr al-Zawr governorate

- 128. At 2200 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in Dayr al-Zawr, wounding one officer.
- 129. At 2300 hours on 25 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Qusur quarter of Dayr al-Zawr, wounding four officers.
- 130. At 1210 hours, an armed terrorist group opened fire on border guards in Dayr al-Zawr.
- 131. At 0130 hours, an armed terrorist group opened fire on the Dayr al-Zawr airport.
- 132. At 0300 hours, an armed terrorist group opened fire on two border posts in the Tall Adas district.
- 133. At 0300 hours, a group detonated an explosive device at the oil pipeline linking the Fidyah and Umar oilfields in the Sabhah district, 35 kilometres east of Dayr al-Zawr. The pipeline caught fire at the point of the explosion.

- 134. At 0700 hours, an armed terrorist group abducted Chief Warrant Officer Ahmad al-'Ali and tortured him to death.
- 135. At 0700 hours, an armed terrorist group abducted a woman, Kahlah al-Durush, the daughter of Colonel Nadir al-Durush, along with conscript Walid Ali, who was driving her to take an examination. The terrorists killed them both.

# Raqqah governorate

- 136. At 2200 hours on 25 June 2012, an armed terrorist group planted an explosive device in the Tawassu'iyah district east of the Jukhadar restaurant.
- 137. At 0100 hours, an armed terrorist group attacked the Abatin border police post in the Tall Abyad district, opening fire on it with machine guns, rocket-propelled grenades and automatic rifles. The men at the post resisted, preventing the assailants from entering it. When the administrator arrived with a patrol vehicle to provide support, he was ambushed: his vehicle came under machine-gun fire, and the tires were riddled with bullets, with the result that he was unable to reach the post. The windows of a vehicle belonging to the Tall Abyad post were also shattered.
- 138. At 0200 hours, an armed terrorist group attacked the Jarniyah and Tabaqah subdistricts, stealing a vehicle belonging to the post, four rifles and a machine gun, and abducting a civilian, Hasan al-Juk, who had attempted to prevent them from launching the attack.

## Hasakah governorate

- 139. At 0000 hours, an armed terrorist group stole a Mercedes, licence plate No. 97182, belonging to the Agriculture Directorate in Hasakah. The incident occurred in Atalah village in the Shaddadah subdistrict.
- 140. At 0130 hours, an armed terrorist group attacked the Tala'i' camp in Hasakah city.
- 141. At 1415 hours, an armed terrorist group commandeered a tanker carrying a quantity of fuel oil as it was proceeding along the road between Shaddadah and Huqul al-Jabasah.

## Ladhiqiyah governorate

142. A patrol vehicle under the command of the Rabi'ah administrator on its way to the Fallah border post was ambushed 200 metres from that post. The administrator was wounded and the men of the patrol surrounded by the armed terrorists. Their fate is still unknown.

#### Syrian-Iraqi border

- 143. At 2300 hours on 25 June 2012, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on the guards manning the Bawaridah border post.
- 144. At 0100 hour, an armed terrorist group opened fire from within Iraqi territory on border guards at Rawdah in the Mayadin district.

145. At 0200 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on the guards manning the Ajrash border post.

146. At 0200 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on the border guards in Abu Kamal in the Baghuth district.

# Syrian-Turkish border

147. At 2000 hours on 25 June 2012, an armed terrorist group attempted to infiltrate across the Turkish border in the Rabi'ah subdistrict of Ladhiqiyah governorate and attacked the police posts there.

## Syrian-Lebanese border

148. At 2200 hours on 25 June 2012, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory.

149. At 2300 hours on 25 June 2012, an armed terrorist group attempted to enter Zabadani through the woods and gardens in the Takiyah district.
