По поручению моего правительства и в дополнение к моим письмам от 16–20 и 23–25 апреля, 7, 11, 14–16, 18, 21, 24, 29 и 31 мая, 1, 4, 6, 7, 11, 19, 20, 25, 27 и 28 июня и 2 и 3 июля 2012 года имею честь препроводить настоящим подробный перечень нарушений плана прекращения насилия, совершенных вооруженными группами Сирии 28 июня 2012 года (см. приложение).

#### Thursday, 28 June 2012

#### Rif Dimashq governorate

- 1. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire on border guards in Yabrud.
- 2. At 0700 hours, an armed terrorist group opened fire on law enforcement officers in Duma, killing Lieutenant Colonel Sadiq Khurma and Conscript Saddam Qantar.
- 3. At 0900 hours, an armed terrorist group opened fire on law enforcement officers in Buwaydah, killing one officer and wounding another.
- 4. At 1100 hours, an armed terrorist group opened fire on the military police department in Qatana and on a law enforcement patrol.
- 5. At 1110 hours, an armed terrorist group opened fire on a law enforcement patrol in Qatana, killing Police Officer Fadi Abbud and wounding three officers.
- 6. At 1500 hours, an armed terrorist group detonated an explosive charge as a law enforcement patrol was passing in the area of Siqba, wounding one officer.
- 7. An estimated 30 armed terrorists stormed the agricultural research station in Nashabiyah, stole a double-cabin pickup, licence plate No. 543785 (Damascus), a tractor without license plates, a rifle and equipment.
- 8. In the city of Tall, an armed terrorist group, riding in a Kia car, license plate unknown, stole a Ministry of Economy Mazda, licence plate No. 663896 (Damascus), from its driver, Ahmad Mustafa Hamid (born 1961).
- 9. Armed terrorists attacked a military construction centre in the town of Sha'ba.
- 10. An armed terrorist group stole two Ministry of Agriculture motorcycles from the 8 March Farm in the town of Sha'ba.
- 11. Safa' Ratib Husayn (born 1968) died as a result of a gunshot wound inflicted by armed terrorists in the town of Misraba.
- 12. Security and law enforcement personnel clashed with armed terrorists in Darayya. No injuries were sustained.
- 13. An armed terrorist group riding on motorcycles in Nabk stole, from Judge Khalid Abdulqadir, a Cham, licence plate No. 663702 (Damascus), a pistol and the judge's personal identity card, judicial identity card and driver's license. Residents of the town of Sahal exchanged fire with armed men in connection with the theft of the judge's car. A number of residents of the town were wounded and rushed to the Yabrud Hospital. Two of them died.

- 14. Armed terrorists deployed heavily on the perimeter of the Duma district.
- 15. In the city of Tall, an armed terrorist group stole a Pajero, licence plate No. 041615 (Damascus), from its driver, a member of the executive office of the Farmers' Union in Damascus, Abdulhadi Sayf.
- 16. An armed terrorist group abducted a civilian, Samih Dib Baladi, in the Tall district.
- 17. Armed terrorists set up a roadblock in the town of Irbin, near the Zamalka arch. The law enforcement forces dealt with them, and no injuries were sustained.
- 18. Chief Warrant Officer Ahmad Qasim was rushed to the police hospital after being shot by armed terrorists as he left his home in Jawbar to go to work.
- 19. Two unidentified bodies with gunshot wounds were found in the vicinity of Darayya. One of the parties was subsequently identified as that of a civilian, Abdulghani Namurah.
- 20. An armed terrorist group stole a Nissan pickup, licence plate No. 573247 (Damascus), from the impoundment garage. The vehicle belongs to the Malaysian Danish White Company.
- 21. An armed terrorist group stole a Toyota pickup, licence plate No. 896108 (Damascus), from its driver, Basil Dahul. The vehicle belongs to the Public Establishment for Electrical Energy.
- 22. An armed terrorist group stole seven computers, a colour computer monitor, two laser printers and five computer tables from the Nakkash School in Darayya.
- 23. The bodies of two unidentified men, both in their forties, were found with gunshot wounds in Ashrafiyah, Sahnaya, in the small village, next to the school.
- 24. A civilian, Issa Umar Abu Hamndah (born 1976), was rushed to Jaramana Hospital after he was shot three times in the crossfire between armed terrorists and law enforcement forces in front of his home in Sha'ba.
- 25. In the town of Nashabiyah, armed terrorists stormed the Syrian–Saudi Company for Agro–Industrial Investments and stole three cars, some of the contents of the cars and a quantity of fuel oil estimated at 25,000 litres.
- 26. Armed terrorists killed a civilian, Abdulrahman Ibn Khalid Abdulqadir (born 1994), in the city of Duma as he was submitting his examination for a second degree.
- 27. An armed terrorist group stormed the home of two drivers for the Shamut Trade Company, Yahya Arif and Jasim al-Damin, and stole two vehicles, a Dong Feng dump truck, licence plate No. 834940 (Rif Dimashq); and a Dong Feng double-deck car carrier, licence plate No. 682157 (Rif Dimashq).
- 28. An armed terrorist group stole a Toyota microbus, licence plate No. 220487 (Rif Dimashq), belonging to the Dibs and Qanbariyah Company for the Manufacture of Tissues.
- 29. Armed terrorists deployed heavily in the Qudsaya district, set up roadblocks and intimidated passing motorists.

30. A number of armed terrorists deployed in vehicles without license plates and motorcycles on the Hamah segment of the Beirut Road and intimidated motorists.

#### **Damascus** governorate

- 31. On 27 June 2012 at 2100 hours, three armed terrorists opened fire on and killed a civilian, Muhammad Amin Tayimaz, in Maydan, on the new Zahirah Highway, under the southern ring road bridge.
- 32. On 27 June 2012 at 2145 hours, an explosive device was found in the vehicle of Colonel Akram Hasan. A military engineering patrol defused the device without causing any appreciable damage.
- 33. At 0100 hours, an armed terrorist group detonated a booby-trapped car at the Palace of Justice garage in Damascus, destroying 25 cars and wounding four civilians.

#### Dar'a governorate

- 34. On 27 June 2012 at 2030 hours, an armed terrorist group opened fire on guards in the vicinity of Raqqad bridge and set fire to a minefield.
- 35. On 27 June 2012 at 2100 hours, an armed terrorist group abducted a civilian, Nasir al-Zu'bi, and Conscript Majdi al-Zu'bi in Tafas. The group tortured and killed them and mutilated their bodies.
- 36. On 27 June 2012 at 2215 hours, an armed terrorist group opened fire on border guards in Dar'a.
- 37. On 27 June 2012 at 2300 hours, an armed terrorist group opened fire on a law enforcement checkpoint in the area of the market in Sanamayn.
- 38. On 27 June 2012 at 2400 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Jizah, wounding one officer.
- 39. On 27 June 2012 at 2400 hours, an armed terrorist group ambushed a law enforcement patrol as it was passing in the town of Kafr Nasij, killing Lieutenant Sa'ir Dib, Staff Sergeant Mahir Wannus and Conscript Hasan al-Manala.
- 40. At 0100 hours, an armed terrorist group opened fire on border guards in Kharab al-Shahm.
- 41. At 0200 hours, an armed terrorist group attacked the Kafr Nasij police station in the Sanamayn district. Personnel at the station returned fire. The exchange of fire continued until 0400 hours. First Lieutenant Rabi 'Sharifah was killed, one officer was injured, five terrorists were killed and two terrorists were injured. Police seized a rifle and two cartridge bags and found a rocket-propelled grenade launcher at the site.
- 42. At 0800 hours, two unidentified bodies of men in their thirties were found in the cemetery of the village of Kuya. The bodies were taken to the Dar'a National Hospital, where an examination showed the two men had been hit by a number of rounds. The bodies were placed in the hospital morgue pending identification by their relatives.
- 43. At 0540 hours, an armed terrorist group opened fire on law enforcement officers in Atman in the vicinity of the party division building.

- 44. At 1000 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the Industry School, wounding two officers.
- 45. At 1100 hours, an armed terrorist group opened fire on guards at the Government complex in Dar'a.
- 46. At 1200 hours, armed terrorists detonated an explosive device in the town of Kafr Shams, wounding three officers.
- 47. At 1400 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of Nu'aymah bridge, killing Corporal Walid al-Bukur.
- 48. At 1500 hours, an armed terrorist group abducted a civilian, Naji Abu Suwayd, on the Muzayrib Jallayn road.
- 49. At 1500 hours, an armed terrorist group opened fire on law enforcement officers in Kafr Shams, wounding seven officers, including two first lieutenants and a colonel.
- 50. At 1800 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of Umm al-Mayadin bridge on the Damascus Dar'a road.
- 51. At 1930 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the Consumer Establishment at the entrance to the refugee camp in Dar'a centre city, wounding one officer.
- 52. Armed terrorists opened fire on the Government complex, the entrance to the refugee camp, Busra Square, the commercial market and Dar'a centre city road in the vicinity of the Establishment for Electrical Energy (Hamadi neighbourhood) to intimidate citizens.

#### Homs governorate

- 53. On 27 June 2012 at 2000 hours, an armed terrorist group opened fire intermittently and fired a rocket from the direction of Bab al-Turkman and the Hashish Market at law enforcement officers in Bab al-Siba'.
- 54. On 27 June 2012 at 2010 hours and 0040 hours, an armed terrorist group opened fire intermittently and fired a rocket from the direction of Bab al-Turkman and the Hashish Market at law enforcement officers in Bab al-Siba'.
- 55. On 27 June 2012 at 2100 hours, an armed terrorist group abducted Conscript Hasan Salih and seized his weapon in the city of Homs.
- 56. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire intermittently at law enforcement officers in the village of Hisn Tall Kalakh.
- 57. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire and fired rocket-propelled grenades intermittently at law enforcement officers on Cairo Street.
- 58. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers in Dayr Ba'lbah, wounding a first lieutenant.
- 59. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire intermittently on law enforcement officers located next to the Jabah restaurant and the Khalid Ibn al-Walid School

- 60. On 27 June 2012 at 2200 hours and 0330 hours, an armed terrorist group opened fire with machine guns and sniper rifles intermittently, fired rocket-propelled grenades and threw hand grenades at law enforcement officers on Cairo Street.
- 61. On 27 June 2012 at 2200 hours and 0300 hours, an armed terrorist group intermittently opened fire with machine guns and sniper rifles on law enforcement officers located next to the Jabah restaurant and the Khalid Ibn al-Walid School.
- 62. On 27 June 2012 at 2200 hours and 0300 hours, an armed terrorist group opened fire intermittently with machine guns and sniper rifles on law enforcement officers in the village of Hisn.
- 63. On 27 June 2012 at 2225 hours, an armed terrorist group opened fire with a sniper rifle from the direction of the Shammas quarter on law enforcement officers located next to the entrance of Masakin al-Idkhar.
- 64. On 27 June 2012 at 2230 hours, an armed terrorist group opened fire from the direction of the Shammas quarter on law enforcement officers located next to the entrance of Masakin al-Idkhar.
- 65. On 27 June 2012 at 2330 hours, an armed terrorist group opened fire and fired a rocket-propelled grenade from the direction of the Shammas quarter at law enforcement officers located next to the 8 March roundabout.
- 66. On 27 June 2012 at 2330 hours, an armed terrorist group opened fire and fired a rocket-propelled grenade from the direction of the Shammas quarter at law enforcement officers located next to the 8 March roundabout.
- 67. At 0600 hours, an armed terrorist group opened fire and fired rocket-propelled grenades and mortars at law enforcement officers in the Sultaniyah quarter, killing two officers and wounding 13.
- 68. At 0800 hours, an armed terrorist group abducted staff Sergeant Ahmad al-Zu'bi in the village of Hamrat.
- 69. At 0900 hours, an armed terrorist group opened fire intermittently on law enforcement officers located next to the citadel.
- 70. At 0900 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades and mortars at law enforcement officers on Cairo Street, wounding one officer.
- 71. At 0900 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers in Jurat al-Shayyah, killing Sergeant Hasan Yazbak and Sergeant Hasan Khalil and wounding nine officers.
- 72. At 0900 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades and mortars intermittently at law enforcement officers in the Khalidiyah quarter, wounding one officer.
- 73. At 1000 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers in the Qusur quarter, wounding one officer.
- 74. At 1000 hours, an armed terrorist group opened fire intermittently on law enforcement officers located next to the Bab Tadmur roundabout.

- 75. At 1000 hours, an armed terrorist group stole a Government truck, licence plate No. 899547, in Talbisah on the Hamah Homs road.
- 76. At 1030 hours, an armed terrorist group opened fire intermittently on law enforcement officers in Wadi al-Sayih and next to the Hubus restaurant.
- 77. At 1030 hours, an armed terrorist group opened fire on the vehicle of the local defence commander as he was headed toward Maryamayn.
- 78. At 1100 hours, for the second time, an armed terrorist group opened fire on law enforcement officers located next to the Jabah restaurant and the Khalid Ibn al-Walid School.
- 79. At 1430 hours, an armed terrorist group opened fire on law enforcement officers located next to the Hal Market roundabout.
- 80. At 1800 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers in the Sultaniyah quarter, wounding one officer.
- 81. At 1800 hours, an armed terrorist group opened fire intermittently and fired rocket-propelled grenades and mortars at law enforcement checkpoints in Talbisah.
- 82. At 1800 hours, an armed terrorist group opened fire with machine guns and sniper rifles and fired rocket-propelled grenades at law enforcement officers in the Sultaniyah quarter, wounding one officer.
- 83. Between 1800 hours and 0200 hours, an armed terrorist group opened fire intermittently with machine guns and sniper rifles and fired rocket-propelled grenades and mortars at a number of law enforcement checkpoints in the city.
- 84. At 1900 hours, an armed terrorist group opened fire, fired rocket-propelled grenades and threw hand grenades intermittently at law enforcement officers in the Qusur quarter, wounding one officer.
- 85. At 1915 hours, an armed terrorist group opened fire on the border guard post in Burayj.
- 86. An armed terrorist group stole a Fiat belonging to the Adra Cement Establishment in the governorate of Homs –Talbisah, licence plate No. 899547 (Damascus). The vehicle contained 8000 empty bags.

#### Hamah governorate

- 87. On 27 June 2012 at 2000 hours, an armed terrorist group planted 13 explosive devices on the road from Suqaylabiyah to Sadd Afamiyah, at Tall Baqlu. Military engineering personnel defused the devices.
- 88. On 27 June 2012 at 2100 hours, an armed terrorist group blew up an empty border guard post in Qusayr.
- 89. On 27 June 2012 at 2120 hours, an armed terrorist group opened fire on and wounded two women in the vicinity of Shaykh Bakr Mosque in the Qusur quarter.
- 90. At 0200 hours, an armed terrorist group opened fire on the new party head-quarters in the Hamidiyah quarter.

- 91. At 0245 hours, an armed terrorist group opened fire on the homes of the Salamah family in the Dahr al-Mughr quarter in the Salamiyah district.
- 92. At 0500 hours, an armed terrorist group opened fire on two vehicles passing on the Suqaylabiyah Asharnah road.
- 93. At 0715 hours, an armed terrorist group planted two explosive devices in the Janub al-Mal'ab quarter. Military engineering personnel defused the devices.
- 94. At 0800 hours, an armed terrorist group stopped a civilian, Abdulrahman Kurdi, at the location of Wadi al-Dawrat, as he was driving his car, licence plate No. 504541, on the Hamah Aleppo road.
- 95. At 0830 hours, an armed terrorist group stole a Government vehicle belonging to the Establishment for Electrical Energy in the Hadir quarter.
- 96. At 1030 hours, an armed terrorist group stole a Government truck, licence plate No. 899005, at the Tumin point on the Hamah Homs road.
- 97. At 1100 hours, an armed terrorist group stole a Government truck, licence plate No. 941229, belonging to the Technical Services Directorate in the Hadir quarter.
- 98. At 1130 hours, an armed terrorist group detonated a booby-trapped motorcycle at the Suqaylabiyah recruitment branch.
- 99. At 1300 hours, an armed terrorist group abducted staff Sergeant Sayfuldin Mu'ayub from in front of his grandfather's house in Kafr Zayta.
- 100. At 1345 hours, an armed terrorist group stole a Government motorcycle belonging to the Water Establishment in the vicinity of Bahrah roundabout in the Tariq Halab quarter.
- 101. At 1530 hours, an armed terrorist group opened fire on a law enforcement forces mess vehicle as it was passing in the vicinity of the village of Bakkarah, Suran sub-district.

#### Aleppo governorate

- 102. On 22 June 2012 at 2000 hours, an armed terrorist group opened fire on a civilian, Ahmad al-Hadi, in Darat Azzah.
- 103. On 27 June 2012 at 2100 hours, an armed terrorist group stormed the Jubb Madi Grain Centre 2 km northeast of the village of Mahdum in the sub-district of Khafsah.
- 104. On 27 June 2012 at 2130 hours, an armed terrorist group stormed the school health clinic in Atarib.
- 105. On 27 June 2012 at 2230 hours, an armed terrorist group stabbed attorney Isam Qabbani and threw his body from the first floor of the Artists' Union Building opposite the Tatan petrol station.
- 106. On 27 June 2012 at 2300 hours, an armed terrorist group opened fire on a civilian, Ziyad Abu Ra's, in the village of Nayrab.
- 107. At 0100 hours, an armed terrorist group used 12 explosive devices to boobytrap a car, which it placed at the entrance to the building of the International Centre for Agricultural Research in the Dry Areas in the A'zamiyah quarter.

- 108. At 0215 hours, an armed terrorist group stormed the International Centre for Agricultural Research in the Dry Areas.
- 109. At 0700 hours, an armed terrorist group dug a hole in the road in the village of Kafr Da'il on the road between Aleppo and Darat Azzah, placed large rocks on the Hawr side of the Abyad turnoff and planted explosive devices.
- 110. At 1000 hours, an armed terrorist group opened fire on law enforcement officers in the Aleppo countryside using all types of weapon, killing one officer and wounding another.
- 111. At 1400 hours, an armed terrorist group opened fire on law enforcement officers in the Aleppo countryside using all types of weapon, killing two officers and wounding nine. The group also abducted three officers, destroyed a vehicle, smashed another vehicle and stole two machine guns.
- 112. At 1600 hours, an armed terrorist group stole a Technical Services Directorate Volvo as it was passing on the Aleppo Bab road near the turnoff to the village of Bazza'ah. The group abducted the civilian driver of the car and two law enforcement officers who were in the car.
- 113. At 1630 hours, an armed terrorist group detonated an explosive device as law enforcement patrols escorting three kerosene tankers from Aleppo to Minakh Air Base were passing in the area of A'zaz, between Hayyan and Anadan, killing Conscript As'ad al-Khalaf, Conscript Isam Turkmani, Conscript Ahmad al-Dalikhah and Sergeant Usamah Mubarak. Eleven officers were wounded, one vehicle was destroyed, another vehicle was damaged and two weapons were also lost.

#### Idlib governorate

- 114. At 0530 hours, an armed terrorist group planted an explosive device on the old Ladhiqiyah Badama road at the Yunusiyah turnoff.
- 115. At 1000 hours, an armed terrorist group abducted First Lieutenant Mustafa al-Dik in the water resources area.
- 116. At 1100 hours, an armed terrorist group detonated an explosive device as a law enforcement patrol was passing on the Ariha Jisr al-Shaghur road at the Hila turnoff, wounding six officers.
- 117. At 1200 hours, an armed terrorist group, numbering an estimated 30 men, stormed the Dana sub-district building, destroyed and stole its contents, cut the telephone wire connecting the sub-district and left the sub-district for an unknown location.
- 118. At 1300 hours, an armed terrorist group planted an explosive device on the Ariha Jisr al-Shaghur road at the Musbin turnoff.
- 119. At 1340 hours, an armed terrorist group detonated a booby-trapped motorcycle in the city of Idlib in front of the Zaytun firm as a law enforcement patrol was passing, killing a civilian, Samir Kurdi Ibn Absi (born 1980), who was a courier in the Health Directorate, as he was passing by the location. The explosion also damaged a patrol car.
- 120. At 1400 hours, an armed terrorist group detonated a booby-trapped motorcycle at a law enforcement checkpoint in the vicinity of the Siyasiyah roundabout in Idlib.

- 121. At 1700 hours, an armed terrorist group opened fire on law enforcement officers in Khan al-Subul on the Ma'arrah Saraqib road using all types of weapon, wounding three officers.
- 122. At 1800 hours, an armed terrorist group opened fire on law enforcement officers at the Ma'arr Dibsah village checkpoint, wounding four officers.
- 123. At 1815 hours, an armed terrorist group detonated an explosive charge as a law enforcement patrol was passing on the Ariha Saraqib road at the Tarnabah turnoff.
- 124. At 1930 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the Ariha bridge, wounding one officer.
- 125. At 1930 hours, an armed terrorist group opened fire on law enforcement officers in Ma'arrah in the vicinity of the Siyasiyah bridge, killing Corporal Yahya Kazkar and Conscript Sha'ban al-Mawwas.

#### Dayr al-Zawr governorate

- 126. On 27 June 2012 at 2030 hours, an armed terrorist group opened fire on soldiers guarding Ward field, wounding one soldier.
- 127. On 27 June 2012 at 2200 hours, an armed terrorist group opened fire on guards at the Tala'i' al-Ba'th Camp.
- 128. At 0100 hours, an armed terrorist group opened fire on the Kamm administration guard post in the area of Tishrin, northeast of Shaddadah, killing Conscript Nasir Yasin, abducting Conscript Muhammad Badawi and stealing their rifles and three cars, licence plate Nos. 574807 and 572913, belonging to the Awdah Oil Company.
- 129. At 0315 hours, an estimated 30 armed terrorists riding in three vehicles attacked the Uraymah sub-district building from three directions, opening fire on the building using different types of weapon and detonating three explosive devices. One explosive device, weighing an estimated 10 kg, which was planted in front of the door to the sub-district building, did not explode. The terrorists were confronted in a clash that continued for approximately 45 minutes.
- 130. At 0930 hours, an armed terrorist group surrounded and attempted to abduct Lieutenant Colonel Ahmad al-Jallad in the area of Huwayjah. A law enforcement patrol freed him, at which point the armed terrorists fired on the patrol, killing Conscript Majdi al-Saghir.
- 131. At 1430 hours, an armed terrorist group attacked the Abu Fas Grain Centre in Shaddadah, wounding one soldier.

#### Hasakah governorate

132. At 0015 hours, a group of approximately 40 terrorists – armed with military rifles, machine guns, rocket-propelled grenade launchers and pistols and riding in five different vehicles – attacked the Awdah Oil Company on the Hasakah – Hawl road. The group clashed with the border guards at Hajanah who were assigned to guard the site, killing Conscript Nasir Muhammad al-Yasin and stealing his rifle and abducting Conscript Nazzar al-Badawi and stealing his rifle. The group also broke the locks on, and stole: a Nissan double-cabin pickup, licence plate No. 573197 (Damascus); a Mitsubishi double-cabin pickup, licence plate No. 572993 (Damascus);

and a Nissan Jeep, licence plate No. 574807 (Damascus). The terrorists set fire to a Mitsubishi Pajero, licence plate No. 995207 (Dayr al-Zawr), which they had been using, after it was disabled by a number of rounds during the clash with the guards. The terrorists then left in the stolen vehicles for an unknown location.

### Ladhiqiyah governorate

133. At 0600 hours, an armed terrorist group attacked a law enforcement station in Uwaynat on the old Aleppo road, setting fire to the law enforcement officers' rooms.
