D'ordre de mon gouvernement et comme suite aux lettres que je vous ai adressées les 16 à 20 et 23 à 25 avril, 7, 11, 14 à 16, 18, 21, 24, 29 et 31 mai 2012, 1^{er}, 4, 6, 7, 11, 19, 20, 25, 27 et 28 juin, 2, 3, 9, 11, 13, 16, 17 et 24 juillet et 1^{er}, 2, 8, 10, 14, 15, 16 et 23 août 2012, j'ai l'honneur de vous faire tenir ci-joint une liste détaillée des violations des dispositions du plan prévoyant la cessation de la violence, commises entre la soirée du mardi 14 août et celle du mercredi 15 août 2012 par des groupes armés en Syrie (voir annexe).
