## PETITION FROM MR. NGOS SIMON CONCERNING THE CAMEROONS UNDER FRENCH ADMINISTRATION

(Circulated in accordance with rule 85 of the rules of procedure of the Trusteeship Council)

Boumndjack, 18/12/56

To: the President of the United Nations Trusteeship Council, New York Sir,

I have the honour to bring a complaint against the representatives and leaders of the U.P.C. whose activities in the Cameroons, particularly in our village on 18 December 1956 were of a kind which could have wiped out the whole country. They burnt down dwellings, destroyed bridges with dynaminte, etc.

In my own case, they set fire to my house, made of sheet-iron, which I built at the end of 1955. The dimensions of the house were 13.40 metres x 7.50 metres, the work on it was finished, the furniture, material and labour cost me 87,000 francs. The roof was left - five huts made of local materials. Ten rooms with beds and mattresses - they took eighty goats belonging to me from my yard and sixty-seven chickens (See attached list of all property).

Now I have become a vagrant, despite my status as father of a family of twelve children and five wives.

I estimate my losses, with out exaggeration, as over 270,000 francs. I consequently make this complaint against the guilty parties in the U.P.C. and request that they should be prosecuted by the Administration with the utmost rigour of the law.

I claim the sum of 270,000 francs as part compensation for the losses I sustained at the hands of the U.P.C.
