### FORTY-FOUR PETITIONS CONCERNING THE CAMEROONS UNDER FRENCH ADMINISTRATION

(Circulated in accordance with rule 85 of the rules of procedure of the Trusteeship Council)

Note by the Secretariat: The petitions circulated in this document are those mentioned in paragraph 6 (a) of the Final Report of the Committee on Communications from the Cameroons under French administration (T/L.671). All contain complaints concerning material, damage and property losses resulting from the incidents of May 1955 in the Mbanga Subdivision, Mungo Region. The petitions have been reproduced in a single document in order to facilitate their examination by members of the Trusteeship Council. The Secretariat has grouped together the various articles enumerated in the excessively long lists attached to certain petitions; in such cases the abbreviated lists are reproduced in square brackets. Certain unduly lengthy portions of the petitions have also been reproduced in summary form and are enclosed in square brackets.

### 1. Petition from Mr. Ignace Kwam

KWAM, IGNACE, planter and member of the Local Committee, Loum, Banana Company, Mbanga subdivision. Mungo Region

Subject: Petition

To: The Chairman of the United Nations
Visiting Mission to the Cameroons

Mr. Chairman.

Since the bloody events which took place in the Cameroons in May, the French colonialists have continued their prosecutions of the leaders and members of the Cameroonian progressive movements.

Mr. Roland Pré, the colonial Governor and representative of France in the Cameroons, still has at his disposal political groups to wage yet another war in the Cameroons, a country under United Nations Trusteeship.

As a result, I, the father of a family of eight persons - KOUM IGNACE, Matodamp Jean, Boujoun Tapia, Manta Salomon, Wantchou André, Kouam Maurice and Kouam Djindjo - have been forced since May to take refuge beneath the trees of the virgin forest in the zone under British administration.

On 29 May, when I was on my way from Nkongsamba to Loum Chantiers, I was searched by a troop of soldiers from the Chad and the Chief Officer of the Loum Sector; they took from me a sum of 70,300 francs, three machetes and a penknife. We ask for the release of our imprisoned brothers and the immediate revocation of the orders issued against Cameroonian political parties.

We call for the establishment of our own Cameroonian Government, under the protection of a United Nations High Commissioner.

In the hope that the United Nations will set up our own system of sovereign government, I have the honour to be, etc.

To: the Chairman of the United Nations Visiting Mission to the Cameroons Sir,

The purpose of the present petition is to submit to your kind consideration the following facts:

As a result of the arbitrary decrees of Mr. Roland Pré, representative of the French Republic in the Cameroons, the Territory has been the scene of a cold war since 26 May last. The prosecutions of the leaders of the progressive movements continue.

I submit herewith a list of my belonging, taken by the colonialists at Loum Chantiers. My hut was not destroyed, but the doors were broken.

In May last, the French colonialists unleashed a war against the population of the Cameroons under United Nations trusteeship, simply because the people had called for its freedom.

In the course of this war, my house at Batougni, with nine rooms measuring twelve square metres, was destroyed by the colonialists and their lackeys supported by military units from the Chad. My house was valued at 136,000 francs (one hundred and thirty-six thousand francs).

I suffered this loss because of the Cameroonian movement. I found my hut was destroyed with the following articles:

They had 8, 4, 10, 5, 3 and 2 rooms respectively.

# 14. Petition from Mrs. Christine (Mamfo) Tchana UNION DEMOCRATIQUE DES FEMMES CAMEROUNAISES

Committee in the maquis, Koumba, 8 September 1955

To: The Chairman of the United Nations Visiting Mission to the Cameroons Sir.

During the historic events of May 1955 provoked by the Roland Pré government, I was the victim of several incidents which deserve to be brought to your attention.

- 1. The mother of two young children aged six and seven respectively, I am living in the <u>maquis</u>, and since the day we were driven away by Pré's "mercenaries" I have been without news of my children.
- 2. These "guardians" of law and order in our country, having failed to find me, as was their first desire, had to destroy my hut, and took from it various belongings and cash, of which the following is a list.
- 1 house or hut whose value I do not know
- 1 sewing-machine (Singer)
- 1 gramophone with records
- l dining table
- 4 chairs
- 1 pair of shoes
- 2 plank beds
- 2 pairs of tennis shoes
- 1 chaise longue
- 2 chests containing various feminine articles and my savings, which total 20,000 francs in cash

- 8. The withdrawal of the two Powers from the Cameroons.

Statement by Mr. Thimba Théodore, mason, married, childless, resident at Mbanga Ville (Mungo Region)

To the Chairman of the United Nations Visiting Mission to the Cameroons Sir.

In May 1955, the French colonialists launched a war against the Cameroonian people. This cold war has resulted in wholesale damage. We have suffered as much in loss of property as in loss of human lives.

The petitioner goes on to deplore the use of armed force on the part of the Administration "to maintain law and order in a country under trusteeship". He adds that France should rather "show its gratitude towards the peoples of the French Union which helped it to throw off the German yoke".

I append below an example of the handiwork of French civilization in the Cameroons. Our "kind masters" searched my hut when they were on our trail, and caused the following damages:

I must explain that I have not listed everything, for the very good reason that I am still in the <u>maquis</u> and have no way of knowing exactly what damage has been caused in my home.

These, Sir, are what the French colonialists and defenders of colonial interests consider satisfactory administrative methods. Even if valid arguments could be advanced in support of this policy, it is manifest that we can never sacrifice the national unification and independence of the Cameroons to the interests of satisfactory administration. Until these legitimate claims of the Cameroonian people are met, we shall continue our struggle.

Until the thousands of Cameroonian men and women are set free to receive the Visiting Mission side by side with those who have been ignored by the French colonialists or silenced by savage repression, it can never be said that the wishes of the people concerned have been FREELY expressed, in accordance with the spirit of Article 76 of the United Nations Charter. Arbitrary mass arrests, illegal prosecutions and looting are not freedom.

#### THEREFORE:

We once again express approval of the JOINT PROCLAMATION of 22 April last calling for the <u>immediate unification</u> and <u>independence</u> of the Cameroons. We protest vociferously against the violation of civil freedoms which is the rule in the Cameroons under French administration. We urge with the utmost vigour the termination of the trusteeship system in our country as from the end of 1955.
