FORTY-TWO PETITIONS CONCERNING THE CAMEROONS UNDER FRENCH ADMINISTRATION

(Circulated in accordance with rule 85 of the rules of procedure of the Trusteeship Council)

Note by the Secretariat: The petitions circulated in this document are those mentioned in paragraph 6 (a) of the Final Report of the Committee on Communications from the Cameroons under French administration (T/L.671). All contain complaints concerning material damage and property losses resulting from the incidents of May 1955. Forty of these petitions emanate from the Mbanga Subdivision, Mungo Region, one from a place which the Secretariat has been unable to locate, and one from an adjacent village in the Cameroons under British administration. The petitions have been reproduced in a single document in order to facilitate their examination by members of the Trusteeship Council. The Secretariat has grouped together the various articles enumerated in the excessively long lists attached to certain petitions; in such cases, the abbreviated lists are reproduced in square brackets. Certain unduly lengthy portions of the petitions have also been reproduced in summary form and are enclosed in square brackets.

- 2. that the French Government of the Cameroons be punished and leave immediately;
- 3. that the immediate unification and independence of the Cameroons be effected, not within the French Union as the traitors advocate, but as one of the interdependent States of the United Nations.

The 600 members of the Coopérative des planteurs africains, having already sent petitions to the United Nations on two occasions, wish once again to draw your attention to these facts.

The two instigators of the robbery and pillage are Mr. Gérard Prestat, Chief of the Mbanga Subdivision, and Father Etienne, a priest of the Catholic Mission at Mbanga.

The members of the Co-operative authorize the Board to surport the Joint Proclamation of 22 April 1970 calling for the immediate unification and independence of the Cameroons.

We ask the United Nations to approve the creation of a Camerocnian State before the end of 1956.

Petition from the Cameroonian Adéfo Sébastien, planter and Chairman of the Coopérative des planteurs africains (C.P.A.), to the United Nations Visiting Mission.

Long live the United Nations;
Long live the Chairman of the Mission!
Long live the independence of the Cameroons!

Sir,

The Government of Mr. Pré has prevailed, or is prevailing, upon the Cameroonians to speak in his favour concerning the incidents of May 1955. Anyone who says anything to the contrary will be persecuted and sent to join the other Cameroonians in the prison at New Bell. But I, one of the first victims of this undeclared war, cannot remain silent and I feel obliged to lay before you, in a petition, the following list of indignities and losses suffered during the raid by the Pré Government.

In the night of 24 April 1955, an armed band under the leadership of Mr. Kamga Joseph, Chief of Bandjour (Bafoussam, my native village, where my wife and three children were living) entered my house to loot and pillage everything. Since then my wife and three children have disappeared. The following is the list of losses sustained that night:

That makes a total of 821,760 francs CFA for Baudjoum.

Let us now proceed to the Mungo region where I am a planter and the Chairman of a Co-operative with 600 members.

On 29 May, it was the turn of Mr. Gérard Prestat, Chief of the Mbanga Subdivision, and Father Etienne, Catholic missionary at Mbanga.

They entered Mungo with a band of men from Chad; it was the end of the month and my clerk was to pay my workers on Monday, 30 May, since I was undergoing a surgical operation in the hospital at Yaoundé.

The following is the list for Mombo, for which Mr. M. Prestat and Father Etienne are responsible:

Plus my plantation which gives me a monthly income of 65,000 francs from banana-growing.

Annual income from coffee 300,000 francs. This is the benefit we derive from article 4, paragraph 1, of the Trusteeship Agreements!

We are looted like this because we demand the immediate unification and independence of the Cameroons. But we are so determined to end the colonial regime that even mass slaughter, arbitrary imprisonment and every type of looting cannot halt our march towards the liberation of our country from colonialist exploitation. Infuriated by the strength of our liberation movement, the French colonialists have unleashed a cold war in the Cameroons, a United Nations Trust Territory. This war has had serious results in the country. Without wishing to enter further into the details already set forth in numerous petitions addressed to the United Nations concerning this savage crime, we call for the punishment of the Roland Pré Government, which is responsible for this military repression.

IN CONCLUSION: We vote for the immediate unification and independence of the Cameroons and, for this purpose, we request the appointment of a United Nations COMMISSION of experts at the tenth session of the United Nations General Assembly to train us in self-government. As a consequence, the Franco-British Trusteeship in the Cameroons should be terminated by the end of 1955.

8. Petition from Mr. Joseph Temdié

Douala, 10 November 1955

To the Chairman of the United Nations Visiting Mission in the Cameroons

DOUALA

Sir,

I have the honour to inform you of my country's misfortune and to express certain wishes.

From the time the High Commissioner, Roland Pré, first arrived in the Territory of the Cameroons, his policy was to abolish the progressive movements in the Territory. He instructed the traditional chiefs to kill the leaders of the progressive movements in the country.

These chiefs, who accepted the status of the movements, refused. He then proceeded to bestow large sums of money or titles on them; still this did not induce them to carry out the High Commissioner's orders. Finally, seeing that his political plan was failing to work, he resorted to arms. Thus he made war on the defenceless Cameroonian people last May.

Several Cameroonians suffered losses as a result of the massacres, imprisonment and, in short, all kinds of criminal outrages.

On Monday, 23 May, I was roughly seized at Mambo where I had gone to buy food for my family. I was severely beaten and thrown into prison at Mbanga. Everything I had on me was taken by the detachment of soldiers: my purse containing the sum of 890,000 francs, 3 pairs of shoes, 1 chest, 6 shirts and 3 pairs of shorts. On the pretext that I was a member of the UPC, I was sentenced to two years' imprisonment. I had left my family, consisting of my wife and five children, all in good health. On my return, two of my children had died of neglect and the others and their mother were seriously ill for the same reason.

Not only my family, but almost all Cameroonians have suffered this fate at the hands of our kind, civilizing masters. I really think that the doctors are making the sick suffer rather than curing them.

I request the present Visiting Mission to effect the release of all political prisoners and the cancellation of the warrants issued for the arrest of the Territory's progressive leaders.

Tatiokam Pierre, planter, Chairman of the Local Committee of the U.P.C.; married, with one child; member of the Mombo Central Committee (C.f.N.)

To the Chairman of the Trusteeship Council's Visiting Mission in the Cameroons Sir,

Following the request for the immediate unification and independence of the Cameroons, the French colonialist Government unleashed an unjust war against the defenceless Cameroonians last April and May. Countless patriots shed their blocd; others were fatally wounded. Most of us are crowded into the prisons of the Cameroons where we are serving savage sentences; some are dead and others are living in the forests like beasts of burden, leaving thousands of families without support or a roof over their heads.

Cur property has been savagely looted; our houses have in some cases been destroyed and in others heartlessly burnt by the colonialist executioners. We learn that you are coming to our country to hold a referendum on the burning question of immediate unification and independence. Accordingly we request you to intercede with the French Government in order to ensure:

The immediate release of political prisoners;

The cancellation of the judicial proceedings instituted against the leaders of the democratic organizations in the Cameroons under French administration;

The withdrawal of the troops whom the French authorities are continuing to assemble in the main regions of the so-called French zone.

Only on these conditions can the Visiting Mission proceed objectively with proper consultations.

Fotso Joseph, planter at Mcmbo Gare, at present residing at Mcmbo, Mbanga Subdivision, Moungo Region.

Married, with two wives, no children; village of origin, Bandjoun, Baufassam Subdivision; region of origin, Baméléké.

To the Chairman of the International Law Commission at the tenth session of the United Nations General Assembly (USA)

Sir,

I have the honour hereby to lodge a complaint against Mr. Roland Pré, the French Governor of the Cameroons, Mr. Presta Gerare, the Chief of the Mbanga Subdivision, and the priest and director of the Catholic Missionary School at Njombé, charging them with taking and looting my property for no reason during the incidents of 29 May 1955 at Mcmbo. I was very surprised to see the armed bands of mercenaries under the administration of the military at Mbanga, whose names are unknown, come and take or confiscate all the property in my house. Considering the atmosphere of terror which prevails at present in the Territory, where the criminals enjoy judicial and administrative immunity and where the victims are prosecuted for their opinions on charges of treason, and considering that the administrative and judicial authority was the instigator of this incident, I consider it useless to submit my complaint to that authority. I request that my case be judged by the International Court of Justice of the United Nations. reserve the right to produce witnesses at the hearing or before the present Hoping that the Visiting Mission's presence will help to Visiting Mission. replace terrorism with international law, I cannot give my full address because warrants are issued for the arrest of those who demand the application of the law. I am filing a civil claim and I shall send you the security required by law through my lawyer, Mr. Ecouër of the Paris Court of Cassation, or through Mrs. Ecouër, because I cannot make out a postal order locally or appear personally at the law courts to deposit the security without my lawyer, because it seems that the postal service is becoming an adjunct of the police department. I am hoping for a satisfactory outcome through your justice.

22. Petition from Mr. Joseph Téguem

Statement by Mr. Teguem Joseph
Planter and member of the UPC Local Committee, Mambo-Gare
To the Chairman of the United Nations Visiting Mission to the Cameroons
Sir,

I am most gratified to learn of your arrival in the Cameroons to ascertain the views of the people of both parts of the Territory concerning the question of immediate unification and independence, and the war launched by the Roland Pré Government in the Cameroons under French administration. I wish, therefore, in this petition to inform you of the course of the war in Mambo-Gare, my normal place of residence before the bloody events of May last.

It was on Sunday, 29 May, that Mambo's turn came to undergo the same fate and to suffer the same consequences of a "civilization" of death and of the sword, as had already befallen Douala, Loum, Manjo and Nkongsamba on 25 May. and Yaoundé, Babimibi, etc. on 26 May. It should be noted that the Priest of Njombe had arrived at Mambo the day before the killings with his scout troops in order to do some training pending the arrival of the mercenaries who were to come a few hours later. But, unanimously repudiated by the population of Mambo, this arrant mercenary, passing himself off as a disciple of Jesus, was compelled to leave the town without carrying out his designs on that occasion. be left to the Chad soldiers under the leadership of five Whites and three priests, all of them armed to the teeth, to put the quarter to fire and sword. They were brought in a special train, which unloaded one contingent of troops 500 metres before the station and a second one 300 metres beyond the station. Ιt should be pointed out that the stationmasters were strictly forbidden to report the arrival of troops.

Led by the Priest of Njombé, who had been at Mambo the day before, and brought up in the manner I have described, the troops surrounded the whole quarter. The extent of the damage and causualties was such that I cannot at the present stage hope to give you the number of the dead, wounded, imprisoned and missing. I should, however, like to point out that both the material losses and the toll of human lives were heavy. It is regrettable to have to note that there were Catholic priests killing defenceless people, those same priests who as "ministers" of God preach that "thou shalt not kill, and shalt love thy brother as thyself". Of

course in the eyes of these Catholic priests, they are not committing evil, for it is not wrong to kill Blacks; it is a minor matter. On the other hand the Whites are the children of a white God, and therefore to kill the Blacks, the children of a black Satan, is to obey their God. Moreover, when they speak of their brothers, they are thinking only of other Whites and therefore they cannot see that there is anything wrong in what they are doing.

Those are the people who seek to live by the sweat of our brows, who kill us and plunder our dwellings and then expect to pass as disciples of Jesus. It would seem that the gates of eternal life are open to brigands, and that the gates of hell are there to let in the innocent. In fact we now know that it is under the cloak of religion that these murderers came to our country to use us as an economic and political material for their colonialist administration. Having failed to win us over by ideology, they think they can perpetuate their colonialist rule by the use of armed force.

Let it suffice to say that we are firmly decided to put an end to the exploitation of man by man, and to the colonial régime.

I append a list of my belongings plundered by Roland Pré's men, and their value.

IN CONSEQUENCE: the immediate unification and independence of the Cameroons are and will remain our first objectives. That being so, we call for the appointment, by the General Assembly, of a United Nations Commission, whose task will be to initiate us in self-government.

I am sure, however, that my house has been ransacked by the French colonialists. At the time of my escape they took 400,000 francs from my briefcase. Once again we declare our support of the joint proclamation of 22 April 1955. We are certain that the Visiting Mission of the Tenth Session of the General Assembly will give the most careful consideration to the memorandum drawn up by the Committee for the Reunification of the Cameroons set up on 24 August 1955 by the most representative organizations from the two parts of our country.

Finally we call for compensation for losses suffered by all the partisans of Cameroonian liberation last April, May and June. The Cameroonian people condemn all petitions inconsistent with Cameroonian national aspirations, for such petitions are written by people from old French colonies in the name of students, planters, notables, or traders in an attempt to distract attention from our national claims. During these events, I was arrested in my workshop by a band of Chad troops. They threatened me with their rifle butts and it was only by chance that I escaped them.

I am the father of a family which comprises eighteen persons and I have not heard anything of their whereabouts since the unleashing of this shameful war.

- 2. We request a United Nations High Commissioner for the Kamerun.
- 3. We request the release of all political prisoners.
- 4. The adoption of a Cameroonian flag, having a red background with a crab in the centre.
- 5. The withdrawal of the warrants for the arrest of our leaders.
- 6. We condemn the "general law" and demand negotiations with the qualified representatives of the Kamerunian national liberation movements with a view to the immediate recognition of a Kamerunian

Report of the property belonging to Mr. Ngoula Lucas, planter, looted during the tragic events of May last in the Cameroons.

To the Chairman of the United Nations Visiting Mission to the

CAMEROONS

Sir,

Cn the occasion of your arrival in the Cameroons to assist with the "referendum", to ascertain the freely expressed wishes of the Cameroonian people concerning the immediate unification and independence of the Cameroons and to learn about the cold war which has had such serious repercussions in our country, I have the honour to submit to you herewith a list of my possessions which were looted by mercenaries under the direction of the French colonialists and their lackeys. During the night of 10 June last I was hidden behind my house and saw a patrol of soldiers, led by the chief of the Mélong sector, enter it. My belongings were then looted and carried off by the colonialists and their lackeys.

There are the benefits conferred upon us by the French Union after forty years of domination. This is the good work done by France the beautiful in the Cameroons.

How can France prove that lootings, killings, massive and arbitrary imprisonments and illegal prosecutions are signposts to a better future? We are absolutely convinced that no arguments can be advanced along these lines.

CONSEQUENTLY:

- 1. We call for the abolition of the Trusteeship System in our country and would like to improve our system of Government with the help of a United Nations High Commissioner.
- 2. We urge the approval of the <u>JOINT PROCLAMATION of 22</u> April last for the <u>IMMEDIATE UNIFICATION AND INDEPENDENCE</u> of the Cameroons.
- 3. We call for the payment of compensation for the losses suffered by the partisans of Cameroonian freedom during May last.
- 4. As the release of political prisoners and the withdrawal of warrants of arrest remain the only means of ensuring a satisfactory inquiry, we extend a welcome to the members of the United Nations Mission and hope they will enjoy their stay both in the Cameroons under French administration and in the Cameroons under British administration.

To the Chairman of the United Nations Visiting Mission to the Cameroons Sir,

As a result of the war unleashed by the French Government against the defenceless Cameroonians in April and May last the blood has been shed of countless Cameroonians struggling like us for the immediate unification and independence of their country. On 14 June the French Administrator at Nkongsarks accompanied by his lackey, Keuni Atoine, foreign chief of Kolla, crossed the frontier arbitrarily imposed on the Cameroons by the former League of Nations in 1918 and burned down my village at Nkount Ndoum in the so-called British Cameroons. The British Government at Kumba was immediately informed by the foreign chief of our locality. I submit below a list of my property damaged by the French Government of Nsamba:
