To the Secretary-General of the United Nations New York, 21, U.S.A.

Sir,

It is with tears in my eyes that I observe the situation in Kamerun since 25 May 1955, when Mr. Roland Pre, French Government in Kamerun, launched a cold war against a people which is asking for the unification and independence of its country.

Speaking for my family and myself, we support the Joint Declaration of 22 April 1955:

CONSEQUENTLY:

I ask for the independence and immediate unification of Kamerun, the appointment of a United Nations High Commissioner in Kamerun, the adoption of the Kamerunian flag, the cancellation of warrants for the arrest of the leaders and representatives of the progressive movements in Kamerun; I attach a statement of my material losses.

6. Petition from Mr. Janvier Nonkam

Nonkam Janvier, planter at Ngol Manten, supporter of the 12 December 1953 Tanko Manjo Committee of the UPC and former political prisoner at the Nkongsamba prison. 5 June 1955, released on 5 March 1956.

Subject:

PETITION

To the President of the eleventh session of the United Nations General Assembly New York, U.S.A.

Sir,

I respectfully submit to you and to the General Assembly the following statement concerning my country, Kamerun, citing the events from the incidents of May 1955 onwards.

In the course of those incidents I was arrested with other Kamerunian men and women and we were imprisoned throughout the territory. Others were shot and fell dead. Others were wounded and others reached the <u>maquis</u>. We therefore request the immediate unification and independence of our dear country.

Recently the French colonialists have been threatening us with the Loi-Cadre, even though Kamerun is not a French colony.

I protest emphatically against the <u>Loi-Cadre</u>. Arbitrary arrests have been playing havor with the people of Kamerun since the incidents of 1955.

I protest against the election of a new A.T.C.A.M. (Territorial Assembly) after the complete unity and victory of Kamerun.

Consequently:

1. I request the immediate Unification and Independence of our country, Kamerun;

- 2. The release of all political prisoners;
- 3. The cancellation of warrants for the arrest of the leaders of the leaders of the Kamerunian progressive movements.

You will find attached my report on the property damaged by the French colonialists in the war of 25 May 1955, by the Government of the French colonies, little Pré in Kamerun.

I reaffirm, in accordance with the numerous petitions sent from Kamerun, that we have sworn to fight until we obtain the immediate Reunification and Independence of our country.

8. Petition from Mr. Gabriel Mounkam

Mounkam Gabriel, planter, member of the Mantem I local committee of the UPC, Nkongsamba Subdivision, Mungo Region

To the Secretary-General of the United Nations New York, 21, U.S.A.

Sir,

At midnight on 2 June 1955 the officer commanding the Nkongsamba gendarmerie, accompanied by TCHAD soldiers, entered my home and arrested me; I was taken, naked, to the Nkongsamba gendarmerie headquarters and imprisoned forthwith. My hut was looted and my property was seized, with the help of the local authorities, and then they asked me about TEGUIA Richard, the U.P.C. secretary in the village of Mantem I, who was disturbing the peace. The village chief called TCHITCHT André said that I was the direct associate of Mr. TEGUIA Richard, the uncompromising UPC member of this village. If I did not answer, I would be condemned to death.

In the NKONGSAMBA cell for political prisoners, there are twenty-five minutes of light a day and the only food a piece of <u>macabo</u> each day. And these political prisoners sleep on the damp cement floor. Numbers of patriots have been arrested, imprisoned, deported, tortured and killed; others have gone to the <u>maquis</u> and some have scattered.

I ask for the immediate unification and independence of Kamerun, the cancellation of warrants issued for the arrest of the representatives and leaders of the progressive movements in Kamerun, the adoption of the Kamerunian flag and appointment of a United Nations High Commissioner in the Territory of Kamerun. You will find attached a statement of my material losses.

Sir,

I have the honour to inform you of the present situation in Kamerun.

Since the incidents of May 1955, Kamerun has been in danger of French colonialist acts of repression, by Roland Pre as well as Messmer; Kamerunian patriots are serving heavy sentences in the cells, only because these peoples claim their legitimate rights.

In the Bafang Subdivision and thereabouts the authorities order the huts of active members to be searched in the absence of the owners; in the village of MBamfam in the same subdivision several active members were arrested and imprisoned, their property was seized, and there were countless wounded.

CONSEQUENTLY

I ask for the immediate unification and independence of Kamerun, the adoption of the Kamerunian flag, the appointment of a United Nations High Commissioner in anticipation of a sovereign Kamerunian State, the cancellation of warrants issued for the arrest of the leaders and representatives of the progressive movements in Kamerun. Speaking for my family and myself, we favour the immediate unification and independence of Kamerun. We ask for the adoption of our Kamerunian flag and the appointment of a United Nations High Commissioner in the Territory of Kamerun. We call for the cancellation of warrants issued for the arrest of the leaders and representatives of the progressive movements in Kamerun. My report is delayed because I was arrested and shut up in a French colonialist cell, from which I was released in March 1956.

YAMI NOAH, political prisoner released on 5 March 1956, and imprisoned on 25 July 1956 in a cell at Nkongsamba because it was proved that I am a Member of the UPC. I do not know what has happened to my family since then.
