- Page 23-25, second line: insert "US" between the dollar sign and 13.
- Page 36, penultimate line: after "operated by" add "voluntary agencies, mostly Christian missions, grant-aided by".
- Page 47, second and third lines: the four last words of the second line and the third line should read: "Director of Lands, Surveys and Mines, other local officers occupy the positions of Chief Electoral Officer". In the fourth and fifth lines, amend "crown prosecutor" to read "Crown Prosecutor".

 "At the same time, to complete the first question asked, my delegation will also raise a question concerning transportation, since this matter was discussed a little while ago, by asking the Administrative Authority and... etc".

- Page 31, first line: delete "announced" and add "begun" after "development"; Fourth line: delete "administration" and substitute "Administrator".
- Page 32, third paragraph, second line: delete "follow this evolution attentively"; substitute "follow the evolution begun attentively".

- Page 3, second paragraph, penultimate line: the word "materials" should be in the plural.
- Page 13-15, second line: change "preduction" to "prediction"; twenty-second line: the word "interest" should be in the singular.
- Page 16, fourth paragraph, third line: add the word "District" after "Palau".

1369th meeting

Page 13-15, seventh line: delete "the two resolutions"; substitute "resolution 1514(XV)". Eighth line: delete "1514(XV) and 2548(XXIV)".

1370th meeting

Page 26-30, before the decision at the bottom of the page, add the following:

"Mr. BLANC (France)(Interpretation from French): To enable my delegation to vote on the proposed amendments, I would wish that the text of these amendments be read out in French by the interpreters".
